Purpose

The Park and Recreation Commission shall consult with and advise the governing body of all matters affecting recreation programs, personnel, finances, and in acquisition and disposal of lands and properties related to all aspects of the County park and recreation program. The Park and Recreation Commission shall establish a supervised system of recreation; acquire lands and structures through gifts, purchases, lease or loan; any grant, gift bequest or donation for recreation purposes; set apart recreation areas and structures and improve such lands; construct and equip buildings and structures as may be necessary to the recreation program within allocated funds. Appointments are made for three-year terms with no one serving more than two consecutive terms.

Qualifications

Three members representing each of the three regions North, South and Central, 1 member representing the northern towns, 1 member representing the southern towns and 2 at-large members. Must be a resident of Mecklenburg County.

Special Notes

Seven (7) appointments:

Five (5) appointments for three-year terms expiring June 30, 2016 (North Region 1 & 3, South Region 1, Northern Town and Central Region 1) effective July 1, 2013.

Elaine Powell (NORT 1), Kendel Bryant (NORT 3), Douglas Burnett (SOUT 1), Travis Dancy (NOTWN) and Sheryl Smith (CENT 1) are all eligible for reappointment.

If the decision was made in the prior agenda item to not reappoint Joseph Pata and Norman Mitchell then the following is applicable.

One (1) appointment to fill an unexpired term expiring June 30, 2013 and a full three-year term expiring June 30, 2016 (At-Large).

One (1) appointment to fill an unexpired term expiring June 30, 2015 (At-Large).

Staff will continue to advertise for the remaining vacancy: Central Region 2 if the decision was made in the prior agenda item to not reappoint Brenda McMoore.
