Purpose

The Nursing Home Advisory Committee serves as a liaison between the Board of County Commissioners and local Nursing Homes. Appointments are made for one-year terms for the first year, and any member reappointed to a second or third- year term will be appointed for a three-year term, with no one serving more than two consecutive terms.

Qualifications

No person or immediate family member of a person with a financial interest in a home served by this committee, no employee or governing board member of a home served by this committee, and no immediate family member of a resident in a home served by this committee may be a member of this committee. Must be able to travel to each facility in the county. Be available to serve an average of eight (8) hours per month. Must be able to complete an initial orientation and field training of 15 hours. Must be a resident of Mecklenburg County.

Special Notes

Two (2) appointments:

One (1) appointment for a three-year term expiring November 30, 2016.

Sharon Morton is eligible for reappointment.

One (1) appointment for a one-year term expiring November 30, 2014.

The Board can nominate and appoint the one eligible applicant, Lennon Maye.

Staff will continue to advertise for the remaining vacancies. Service on this committee requires a tremendous time commitment. There's also mandatory training which is conducted by the Ombudsman at the Centralina Council of Governments.
