Purpose

The Region F Aging Advisory Committee advises the staff and Centralina Council of Government Board on the Area Plan, allocation of funds, etc. Appointments are made for two-year terms or three consecutive two-year terms which equals a total of six years. Alternates (ALT) serve for a one-year term. Persons having served as alternates are eligible to serve as full members when a delegate (DEL) slot becomes open. Delegates rotating off can move to an alternate slot.

Qualifications

Members cannot be employed with an agency which is receiving Older American Act Funds. At least 50% of appointees should be over 60 years of age. Must be a resident of Mecklenburg County.

Special Notes

Two (2) appointments:

One (1) appointment for a two-year term expiring June 30, 2015 (Delegate).

One (1) appointment for a one-year term expiring June 30, 2014 (Alternate).

The Board is being asked to exercise the exception provision of its Appointment Policy - Membership Terms, Sect 4-A, which states Except in extraordinary circumstances it shall be the policy of the Board that terms of membership shall be staggered and that members serve not more than two full consecutive terms. Clarissy Knox and Marilyn O'Connor have served two full consecutive terms and are willing to continue, since no one else has expressed an interest in serving. Staff recommend they be reaappointed. Staff feels this qualifies as an extraordinary circumstance for reappointment.

Staff will continue to advertise for the remaining vacancy.
