Purpose

The Board of Equalization and Review hears appeals of taxpayers on assessed values and reviews current assessments made by the Tax Assessor. Appointments are made for three-year terms with no one serving more than two full consecutive terms. The Chairman and Vice-Chairman are designated by the Board of County Commissioners.

Qualifications

To qualify for appointment as a member, each nominee to the Board shall be of good moral character, shall have resided in Mecklenburg County at least two (2) consecutive years prior to the appointment, shall remain as a resident for the duration of service as a member, shall be knowledgeable of real estate or personal property valuation matters, and shall not have been convicted of a felony.

(Note: FMRMB stands for Former Member)

Five (5) appointments for one-year terms expiring April 16, 2014.

Five (5) appointments for two-year terms expiring April 16, 2015.

Five (5) appointments for three-year terms expiring April 16, 2016.
