Purpose

Acting under the authority delegated by City Council and the Mecklenburg County Board of Commissioners the Ten Year Plan to End and Prevent Homelessness Community Based Board, which has been named the Charlotte Mecklenburg Coalition for Housing, shall be responsible for:

- Recommend annual priorities for housing programs and development
- Development of policy recommendations that impact housing and homelessness
- Recommend Annual Capital Funding Allocations
- Annual plan evaluation/assessment/action plans
- Annual Report to City Council and County Commission
- Partnership development and alignment of services
- Advocacy
- Data collection and reporting

Qualifications

Must be a resident of Mecklenburg County

The membership of the "Ten-Year Plan Committee shall include representatives from the following categories:

- Public Safety/Law Enforcement: One professional with demonstrated knowledge, interest and experience in the Public Safety/Law Enforcement Field
- Human Services: One professional with demonstrated knowledge, interest and experience in the Human Services Field
- Education: One professional with demonstrated knowledge, interest and experience in the Education Field

Two (2) appointments:

One (1) appointment for a three-year term expiring June 30, 2016 (Human Services representative).

Annabelle Suddreth is eligible for reappointment.

One (1) appointment to fill an unexpired term expiring June 30, 2014 (Public Safety/Law Enforcement representative).

The Board can nominate and appoint the one eligible applicant, Josef Penner.

Frank Cantrell resigned due to work constraints.

experience : Annabelle has lived in our community for 25 years and has served in the area of homelessness as either a volunteer or employee for 14 years. As a volunteer, she was instrumental in the implementation of Room in the Inn (a church-based winter shelter program at the Urban Ministry Center) and later served as Development Director and Assistant Director at the Urban Ministry Center. Her resume (attached) includes 17 years of for-profit technology staff and management experience as well as an MBA from Queens University.

Since 2006, Annabelle has served as the Executive Director of A Child's Place, a local non-profit working to erase the impact of homelessness on children and their education. She leads her team in an effort to serve our community's 3,200 identified homeless children to meet their basic and educational needs.

Annabelle helped lead our community's Hall House effort, a partnership with Charlotte Housing Authority, Mecklenburg County Department of Social Services, Salvation Army, Charlotte-Mecklenburg Schools and A Child's Place that housed 69 homeless families for the cold winter months in 2009. After 5 short months of housing and supportive services, 78% of these families moved into stable housing.

Annabelle also serves on our community's Project HOPE Advisory Board. This Board advises Project HOPE, Charlotte's Rapid Re-housing program that is funded with nearly \$2 million in

federal stimulus money that seeks to create a best practice model for moving people from homelessness to housing. A Child's Place is a member of:

- the Homeless Services Network, a coalition of 37 nonprofit, government and faith-based programs devoted to ending homelessness in Mecklenburg County
- the Children's Alliance, an alliance of 60 nonprofit and government organizations dedicated to issues related to the children in Mecklenburg County
- the Children and Family Services Center, a collaboration of nine agencies that offer comprehensive assistance to strengthen children and families.

skills : A Child's Place is not in the housing business but has strong interest in seeing children in our community housed in supportive and appropriate housing. Our agency receives no City or County funding. A Child's Place has just launched a 3-year plan to help all identified homeless children while collaborating on community initiatives to reduce the number of homeless children. I can think of no other way to help reduce the number of homeless children in our community than to help them find supportive and appropriate housing.

The number of homeless children in Charlotte-Mecklenburg Schools has grown 20% every year for the past 5 years. Having over 3,200 homeless children in Charlotte is a statistic none of us can be proud of. What we can be proud of is how we deal with the situation. We can continue to look at the statistic and be ashamed or we can roll up our sleeves and get to work to show our community and the country that we can do better. I am knowledgeable about the needs of homeless children, passionate about their supportive services and education and qualified and ready to serve on the Homeless Prevention Community Based Board.

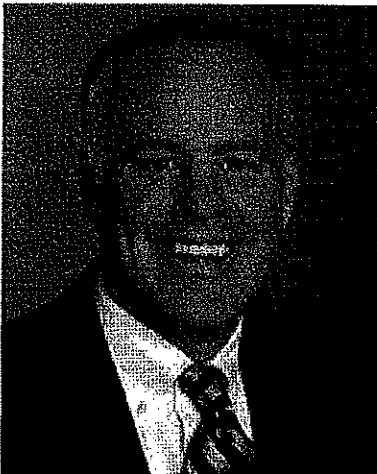

The CMCH is a community-based board established in 2010 to implement the Charlotte Mecklenburg Ten-Year Plan to End and Prevent Homelessness. Board appointments are made by the Mayor, City Council and Board of County Commissioners.

Per the CMCH's membership rules adopted by the Charlotte City Council, Board of County Commissioners and the Foundation for the Carolinas, the appointment of the CMCH Chair shall rotate between City, County and Foundation for the Carolinas. Charlotte Mayor Foxx appointed Mike Rizer as the first CMCH Chair to serve for three years. That term expires on June 30, 2013 and the ex-officio members of the CMCH (representatives of the City, County and Charlotte Housing Authority) are recommending Mr. Rizer be reappointed as Chair by the Board of County Commissioners. This recommendation for reappointment is being made to ensure consistency in leadership at this critical time, especially considering the projects that are in initial stages of development, as follows:

- 1. An affordable housing and homelessness data consortium partnership with the Institute for Social Capital at UNC Charlotte for annual reporting**
- 2. The establishment of a \$20 million endowment at the Foundation for the Carolinas, which will support a local rental assistance program serving families earning 50% (\$32,550) and below the area median income**



Mike Rizer, Chairman

Joined Wachovia Corporation (now Wells Fargo) in 1996 and has been its Executive Vice President/Community Development Director since January 2009. In this role he manages the nationwide Community Development team which is responsible for CRA performance, community outreach, key internal and external relationships and reputation risk. Additionally, he provides leadership to the Wachovia Regional Foundation/CDC located in Philadelphia. Prior to his current position, he was the Director of Community Relations. Mr. Rizer was Senior Compliance Manager and Counsel for PNC Bank Corporation from 1991-1996. He started his professional career as an attorney with the Legal Aid Society of Cincinnati. He received his BA from the University of Dayton and his JD from the University of Cincinnati. He is very active in the community and serves on the boards of the National Center for Healthy Housing, the North Carolina Equal Access to Justice Commission, Mecklenburg Citizens for Public Education, the Echo Foundation and the Foundation for The Carolinas.
