Purpose

The Juvenile Crime Prevention Council (JCPC) is the local organization charged by the N.C. General Assembly to plan, organize, and evaluate locally-based programs designed to prevent and mitigate juvenile delinquency in Mecklenburg County. Specifically, the JCPC is to develop community-based alternatives to training schools and to provide community-based delinquency and substance abuse prevention strategies and programs.

Qualifications

Must be a resident of Mecklenburg County. The membership of the Juvenile Crime Prevention Council shall include representatives from the following categories:

1. Youth under the age of 18 (YTH) - 1 member
2. General Public (GP) - 7 members
3. Faith Community (FAITH)- 1 member
4. Substance Abuse Professional (SAP) - 1 member
5. Non-Profit (NP) - 1 member
6. Business Community (BUS) - 1 member
7. Juvenile Defense Attorney (JDA) - 1 member

Special Notes

Five (5) appointments for two-year terms expiring June 30, 2015 (General Public (GP), Business Community (BUS) and Substance Abuse Professional (SAP) representatives).

Douglas Edwards (GP), Laura Johnson (BUS), Susan McCarter (GP) and Mary Lisa Moore (GP) are all eligible for reappointment.

The Board can nominate and appoint the one eligible applicant, Jane Goble-Clark as the Substance Abuse Professional representative.

Lopa Thakkar resigned to pursue other professional endeavors.

Staff will continue to advertise for the remaining vacancies: Juvenile Defense Attorney and Youth Representative.
