Number of BOCC Members: 13 Term Length in Years: 3

Purpose

The BDC shall review, advise and make recommendations to the Board and the Department regarding: land development/building industry matters; the annual budget of County departments with land development/building regulatory functions; the methodology for establishing and the level of all fees charged; land development/building regulatory programs, processes, plans, and procedures for efficiency and effectiveness, etc. The BDC shall assist, advise, and make recommendations to the Department as needed. The BDC shall organize and administer subcommittees for the licensing of certain construction trades as required by law.

Qualifications

The BDC shall be composed of persons who are qualified, by experience and training, to consider and determine matters pertaining to building construction and who are residents of Mecklenburg County. The BDC shall consist of one representative recommended by each of the following organizations and appointed by the Board: Master Electrical Contractors Assoc. of N.C. or Charlotte (MECA); Professional Engineers of North Charlotte (PENC); American Society of Landscape Architects (ASLA); Charlotte Heating & Air Conditioning Contractors Assoc. (HAC); American Institute of Architects (AIA); Mecklenburg General Contractor's Assoc. (MGCA); Charlotte Chamber of Commerce (CCham); Home Builders Assoc. of Charlotte (HBA); Charlotte Plumbing, Heating and Cooling Contractors Assoc. (PHC); Charlotte Apartment Assoc. (CAA); National Association of Remodeling Industry (NARI); Two General Public Members (GP). Representation of the above organizations on the BDC is not limited or restricted to membership in the organizations. All applications from those interested in serving on the BDC shall be provided to the Board for its consideration. Must be a resident of Mecklenburg County.

The Chairperson is appointed by the Board and shall be the Charlotte Chamber of Commerce representative.

Special Notes

Two (2) appointments for three-year terms expiring July 31, 2016. (Charlotte Chamber of Commerce (CCham) and General Public (GP) representatives).

Jonathan Bahr (CCham) and Kevin Silva (GP) are both eligible for reappointment. The Board will also need to appoint a Chair. Jonathan Bahr currently serves in this capacity and is willing to continue.

Staff will continue to advertise for the remaining vacancies, Master Electrical Contractors Assoc. of N.C. or Charlotte, American Institute of Architects and General Public.
