Purpose

The purpose of the Industrial Facilities and Pollution Control Financing Authority is: 1) to aid in the financing of industrial and manufacturing facilities for the purpose of alleviating unemployment or raising below average manufacturing wages by financing industrial and manufacturing facilities which provide job opportunities or pay better wages than those prevalent in the area, but only where there is a direct or indirect favorable impact on employment commensurate with control facilities for industry in connection with manufacturing and industrial facilities and for public utilities, but only where there is an improvement in the degree of prevention or control of pollution commensurate with the size and cost of the facilities, and 2) to conduct any and all other activities as shall from time to time be found to be appropriate in connection with the foregoing and as are lawful under the Act, as the same may be from time to time amended.

Qualifications

Appointments are made for six-year terms with no one serving more than one term. Must be a resident of Mecklenburg County.

Special Notes Three (3) appointments for six-year terms expiring October 31, 2019.
