### Prioritization Rationale

- Ranks projects across purposes
- Introduces Board of County Commission priorities into the capital process for all entities
- Permits data driven decisions about how scarce capital funds should be prioritized
- Capital funds are allocated equitably

### Project Evaluation and Ranking Process

#### **Process:**

- 1) Projects must begin prior to July 1, 2016
- 2) Maximum total projects submitted per entity not to exceed \$300M
- 3) Include land acquisition needs with project
- 4) Will consider a phased approach to project ranking


