

## Default Resolved with Traditions Golf Course Management Company

As Board Members will recall from the January 11 *Board Bulletin*, the Park & Recreation Department staff recently issued a default letter to The Tradition Golf Course, LLC (TGC). TGC is the company that manages the County-owned golf course on Prosperity Church Road in north Charlotte. The default letter was issued for non-payment of rent, late fees and junior golf fees with a cure date of December 26, 2012; and other defaults, such as failure to maintain a letter of credit, failure to maintain the golf course, parking lot and golf cart storage area, failure to maintain adequate equipment and failure to maintain adequate golf course staff. The letter provided a cure date of January 15, 2013 at 5 pm.

Since that time, TGC has paid all outstanding rent, late fees and junior golf fees through December 31, 2012 to cure the non-payment default. In addition, following the wire transfer of a \$50,000 security deposit this week, the

management company has now resolved the final default issue and therefore is in full compliance with our agreement, allowing it to continue operating the course.
