Staff Response(s)	1. The current policy allows employees time away from work to participate in school-related activities and volunteer with approved community service agencies to receive up to 24 hours of matched time. Community service agencies that wish to have County employees volunteer with them must contact the County Manager to be approved as a participating agency. This list of organizations has not been updated since 2008.
	As stated above the list of community service agencies has not been updated since 2008. On the current list there are agencies that need to be removed because they no longer exist, or name has been changed. We are recommending the chart be moved to the HR Policy section as we anticipate an increase in changes more often as employee's recommend agencies.
	Employees have been requesting to add agencies to the list, however under the current policy there is no avenue for employees to do so. Agencies must be a non-profit or charitable organization. The organization's vision, goals, and mission must be in alignment with the County's vision, goals, and mission. The County Manager would approve it as a participating agency.
	There is no fiscal impact. Employees are allotted 24 hours each calendar year for volunteer/school related activities.

Staff Response(s)	The North Carolina Department of Public Safety (NCDPS) requires each JCPC funded program provide a 30% match. The match may be in-kind, cash or a combination of both. If need be, programs may adjust the amount of its match during the funded year. When this occurs, NCDPS requires local boards of county commissioners approve match changes on the annual funding plan. In this instance, the Youth Development Initiative is increasing the amount of its in-kind match. Youth Style Fitness is changing a portion of its match from in-kind to cash.

Staff Response(s)	 This is a partnership with Charlotte-Mecklenburg Schools (CMS) to split the cost for installation of an irrigation system at E.E. Waddell High School football field, allowing Park and Recreation to use the field to host all athletic rentals that were scheduled at Southside Park for at least the next 2 years. Southside Park has been closed for evaluation/testing from the recommendation of NC Department of Environmental Quality (DEQ). CMS is reimbursing the County for half the cost of the irrigation system to maintain the field at game ready standards. Receive and appropriate an increase of \$14,900 in revenue to Park and Recreation general fund (0001) for reimbursement for irrigation installation

Staff Response(s)	1. In partnership with Mecklenburg County and Atrium Health, Legal Aid of North Carolina-Charlotte (LANC) proposes a hospital-based violence intervention program in Charlotte to deliver civil legal assistance to victims of violence. Atrium will identify trauma patients affected by violence and refer them to a LANC attorney funded through this grant. The LANC attorney will provide legal information, advice, and representation related to housing, safety, and other stability-focused needs. The overall goal of the grant project is to contribute to a reduction in gun violence and its impacts.
	2. This grant application seeks funding via the North Carolina Governor's Crime Commission (GCC) from federal funds appropriated to the State Crisis Intervention Program (BYRNE-SCIP) and Community Violence Intervention and Prevention Initiative (CVIPI). The GCC supports the development of comprehensive projects that include collaborative partnerships with multiple agencies (e.g., human service agencies, court and criminal justice agencies, universities, etc.). For this project, the County will support coordinated case planning and wraparound referrals, Atrium will identify and refer trauma patients affected by violence, and LANC will provide legal information, advice, and representation related to housing, safety, and other stability-focused needs. The overall goal of the grant project is to contribute to a reduction in gun violence and its impacts.
