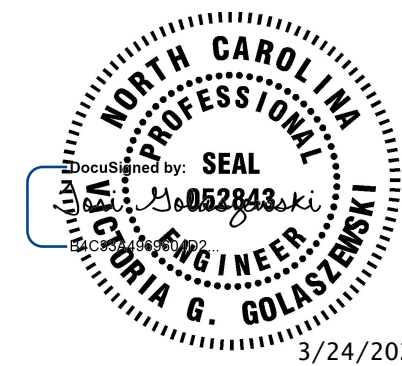

### Project Description:

The project includes 3,778 LF (0.72 miles) of new Greenway construction. The mainline greenway will construct a 12-foot-wide greenway for 0.44 miles through Chantilly Park, starting at Bramlet Road, following Briar Creek, then ending at Bay Street. The first connection will construct a 12-foot-wide greenway for 0.19 miles, beginning at the end of Wyanoke Ave then entering Chantilly Park to intersect with the mainline greenway once it crosses Briar Creek. The greenway will include one prefabricated pedestrian truss bridge spanning Briar Creek and a 36-car parking lot on Bramlet Road. The greenway will also include approximately 0.1 additional miles of 10-foot-wide connectors that will tie the greenway into neighborhood access points and existing creek crossings.
