#### *Purpose*

The Nursing Home Advisory Committee serves as a liaison between the Board of County Commissioners and local Nursing Homes. Appointments are made for one-year terms for the first year, and any member reappointed to a second or third- year term will be appointed for a three-year term, with no one serving more than two consecutive terms.

#### *Qualifications*

No person or immediate family member of a person with a financial interest in a home served by this committee, no employee or governing board member of a home served by this committee, and no immediate family member of a resident in a home served by this committee may be a member of this committee. Must be able to travel to each facility in the county. Be available to serve an average of eight (8) hours per month. Must be able to complete an initial orientation and field training of 15 hours. Must be a resident of Mecklenburg County.

#### *Special Notes* APPOINTMENTS NEEDED FOR:

(A) Two (2) three-year terms expiring September 30, 2023

- The Ombudsman is requesting that Larry Blakeney and Jeffrey Giddens terms be continued. See attached recommendation.

(B) One (1) three-year term expiring August 31, 2020

- Robert Bruton is eligible for reappointment.

(C) One (1) three-year term expiring October 31, 2023.

- Tarshia Faniel is eligible for reappointment.

**Note:** The remaining applicants are pending screening by the Ombudsman at the Centralina Council of Governments and will be brought forth at a later date.

**Service on this committee requires a tremendous time commitment. There's also mandatory training which is conducted by the Ombudsman at the Centralina Council of Governments. The Nursing Home Advisory Committee is one of six advisory boards that receive compensation. Members receive \$75/month.**

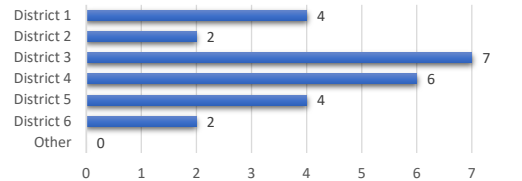

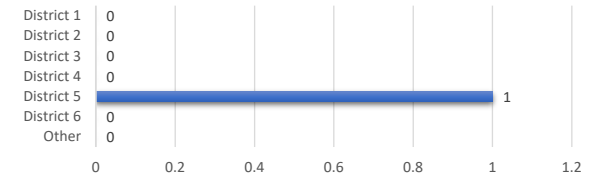

Members by District



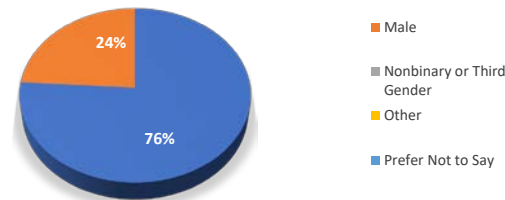
Applicants by District



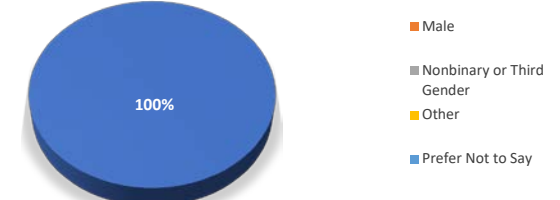

Members by Gender



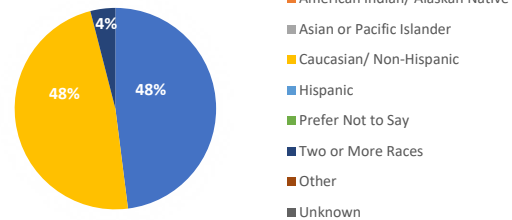
Applicants by Gender



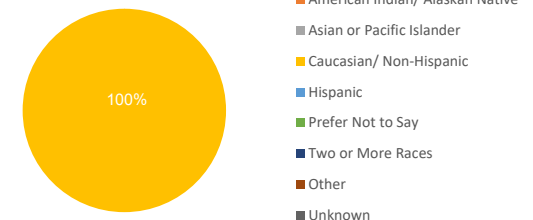
