Dear Mr. Sanford:

Four bids were received for the Interim Material Recovery Facility (project) on Friday, January 26, 2024, at the Mecklenburg County Land Use and Environmental Services Agency in Charlotte, North Carolina. This letter presents CDM Smith's evaluation of the received bids and our recommendation for lowest responsible bidder. As indicated in the project manual, the project was bid with a Total Bid Amount consisting of unit price and lump sum bid items. CDM Smith evaluated the bids based on the Total Bid Amount submitted by the contractors.

The project involves site development including excavation and backfill; grading; utility construction; scale installation; erosion and sedimentation control; concrete and asphalt pavement; concrete footings and foundations; electrical and lighting; and landscaping. Work to be completed by others, but in coordination with the contractor includes installation of processing and storage buildings; installation of processing equipment; set up of a scale house and mobile office; installation of a fire suppression system; and installation of utility crossings underneath Pence Road.

BID EVALUATION

CDM Smith evaluated the bids based on whether the bidder submitted all information as required by the project manual.

Exhibit 1 lists all bidders, the information requested to be included in the bid packages, and a summary of the bid amounts as publicly opened at the bid opening. Ground Thunder Construction, Inc. (Ground Thunder) was the apparent low bidder after the public opening of the bids.

REVIEW OF BID PRICES

Each bid was reviewed for mathematical errors and other discrepancies. **Exhibit 2** provides a complete certified bid tabulation for your review. Exhibit 2 includes notes that explain any

mathematical errors or discrepancies identified during our review, and adjustments made to contractors bid amounts.

The revised Total Bid Amounts (from low to high) based on our evaluation and mathematical adjustments is as follows:

- Ground Thunder's bid contained discrepancies between the unit price and bid item total amount for Bid Item 8. The discrepancy was resolved in favor of the unit price with a revised bid item total amount of \$7,525.00. Ground Thunder wrote out the bid item total amount instead of the unit price for Bid Items 12, 13, and 20c. The bid item total amount for these items was calculated correctly and remains unchanged.
 - There is a discrepancy in J. M. Cope's bid form between the unit price and the bid item total amount for Bid Item 28. The discrepancy appears to be an unintentional error and was resolved in favor of the unit price. The revised bid item total is \$59,167.00.
 - AVM Contractor's bid contained discrepancies between the unit price and bid item total amount for Bid Items 3, 21, and 24. The discrepancies were resolved in favor of the unit prices. The bid also contained a discrepancy between the unit price in words and the unit price in figures for Bid Item 28. The discrepancy was resolved in favor of the unit price in words in accordance with the project manual. The revised bid item total is \$49,412.39.
 - The bid subtotal, 5% base bid contingency, and bid total presented have been revised after resolving the discrepancies noted above.
