Dear Ebenezer,

As the Chair of the Environmental Stewardship Committee for Mecklenburg County and as someone who knew Rusty Rozzelle as a water quality professional for more than thirty years, I am writing to offer my full support to formally rename the Suttle Avenue LUESA building after him.

I first learned about Rusty's good work with respect to water quality when I worked in healthcare, before I met him in-person. I was there when Rusty was honored with an *Environmental Hero* award from the Blumenthal Foundation in the early nineties. I believe he spent every day for the rest of his life proving that he was a hero for the environment.

He was a lifelong dedicated public servant, who woke up every day for 45 years to face the never-ending challenges of environmental stewardship and a person who did everything that he could to make a positive difference.

Facility Naming Policy Supporting Documentation for

Rusty Rozzelle

With over 45 years of service in local government as the Water Quality Program Manager for Charlotte-Mecklenburg Storm Water Services, Rusty Rozzelle has spent his career dedicated to the mission of preserving and restoring our local surface water resources. His career has included many significant achievements that have set the foundation for water resource management on a local, regional, and state level.

If you've ever enjoyed a stream by a greenway, gone fishing in a local pond, or enjoyed a day on Lake Norman, you've been impacted by the work of Rusty Rozzelle. He was an outstanding team member, mentor, confidant and servant leader, who exemplified dedication and commitment to the community," said LUESA Director Ebenezer Gujjarlapudi. "He was a consummate professional who lived out his calling to protect our natural resources and his legacy will continue because of his great work."

Rusty's greatest strength and contribution to the community is was his ability to bring groups (with oftentimes different goals/needs) together and leading them to consensus on initiatives that balance growth in the area with protection and preservation of water resources, which has made Mecklenburg County an attractive place to live. Rusty's passion for water quality and collaboration enabled Mecklenburg County, the Towns of Cornelius, Davidson, Huntersville, Matthews, Mint Hill and Pineville, Central Piedmont Community College and Charlotte-Mecklenburg School System to obtain the first joint National Pollutant Discharge Elimination System (NPDES) permit in the State of NC, which provided provides for good/efficient government and consistent water quality protection throughout the County.

Rusty ensured the ultimate protection of local lakes and streams through the development, adoption, and implementation of multiple protective ordinances for Mecklenburg County, the City of Charlotte, and the Towns of Cornelius, Davidson, Huntersville, Matthews, Mint Hill and Pineville. Beginning in 1993, he developed the Water Supply Watershed Buffers to help protect the public water supplies in Lake Norman, Mountain Island Lake, and Lake Wylie. In 1999 and 2000, the Surface Water Improvement and Management (SWIM) Buffer Ordinance was adopted to help protect our water quality by filtering out pollutants in stormwater runoff. Rusty worked with the Town of Huntersville in the adoption (2003) of a Low-Impact-Development (LID) Ordinance which has been a significant measure to balance water quality impacts from the tremendous amount of development that has occurred within this community.

In 2008, he played a pivotal role in navigating a group of stakeholders to agree on common goals for Mecklenburg County and reaching consensus to adopt a Post-Construction Stormwater Ordinance which is aimed at managing stormwater runoff after construction is complete to improve water quality and protect our stream systems. This effort involved weekly after-hours meetings that lasted 18 months. Included in the Post-Construction ordinances were provisions that provided protection of the Carolina heelsplitter, which is a federally-endangered species of freshwater mussel. Rusty has been a champion in improving and protecting surface waters for all residents of Mecklenburg County as well as throughout the State of NC and the southeast. Rusty has an eloquent way of using history (starting in the late 1700's when his family operated Rozzelles Ferry, one of the first

ferry's across the Catawba River), story-telling, and environmental science to educate people on the importance of preserving waters of the State and was often called upon to give talks and presentation to elected officials, historical societies, and environmental groups throughout NC.

Naming/Renaming Steps

Step 1

• We are made aware of an intent to apply for a naming/renaming

Step 2

• Letter goes from the Director to the County Manager/BOCC to notify them of an upcoming application for naming/renaming

Step 3

 The application, petition, background check and letters of support are completed and input is solicited from the BOCC of that district.

Step 4

Application is presented at 3 public meetings

Step 5

• Complete application and request for public hearing goes on the BOCC agenda. Notification is posted by the Clerk to the Board in the local paper 10 days in advance of the hearing.

Step 6

• Complete application and request to open the public hearing goes on the BOCC agenda for approval.
