### **Purpose**

The Zoning Board of Adjustment an eight member Board. This includes five regular members and three alternates. Five members are appointed by the Charlotte City Council, two are appointed by the Mayor of Charlotte, and one is appointed by the Mecklenburg County Commission. The appointments are for three years and each member may serve two consecutive terms. The Zoning Board of Adjustment has the authority to hear and decide appeals from a decision made by the Zoning Administrator and to hear and decide petitions for variances from the requirements of the Zoning Ordinance. The appointee must live in the City of Charlotte ETJ.

### Qualifications

Appointments are made for three-year terms with no one serving more than two consecutive full terms. The appointee must live in the City of Charlotte ETJ (i.e. not living within the City limits but within the City's zoning jurisdiction)




