V. Name of civic/community activities, position of leadership and dates of involvement:

As Chairman of the Little Rock A.M.E. Zion Church Board of Trustees, Mrs. Wilson led the early efforts to fight Charlotte's Urban Renewal efforts to demolish her neighborhood and the family's home church, the Little Rock AME Zion Church on North Myers Street, Charlotte, NC. Instead, due to her efforts and others, in 1969 the original church at 401 North Myers Street was saved and later sold to the City of Charlotte. In 1981, she led fundraising efforts to rebuild a \$1.8 million-dollar new Little Rock AME Zion Church at 401 North McDowell Street, Charlotte, NC. Mrs. Wilson also served as coordinator for the 43rd Quadrennial Conference of the AME Zion Church and helped recruit over 650 volunteers.

VI. Organizations and positions held: In 1978, Mrs. Wilson was named Director of Youth and Family Services, the first African American Program Administrator at the Mecklenburg County Department of Social Services.

First African American promoted as a program administrator at the Mecklenburg County Department of Social Services. Mrs. Wilson served as the program administrator/director for Youth and Family Services.

VIII. Additional comments: Mrs. Catherine M. Wilson joined the Mecklenburg County Department of Social Services in 1949 during the Jim Crow era. She recalled working out of a one room office with four other social workers. Black social workers were relegated to working with Black families only, while white social workers were eligible to work with both Black and white families. By 1968, according to the Charlotte Observer, out of 101 social workers, Mrs. Wilson was the only African American social worker at the Mecklenburg County Department of Services.
