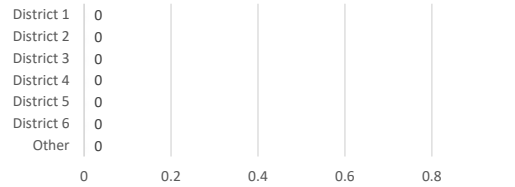

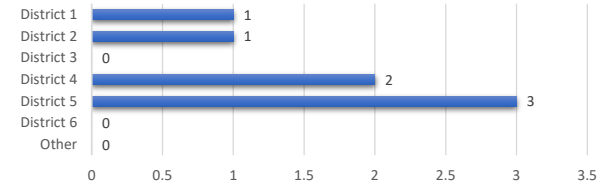

Members by District



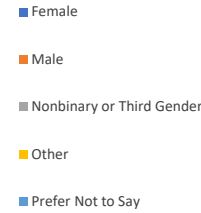

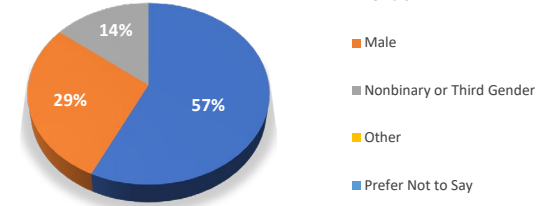

Applicants by Gender



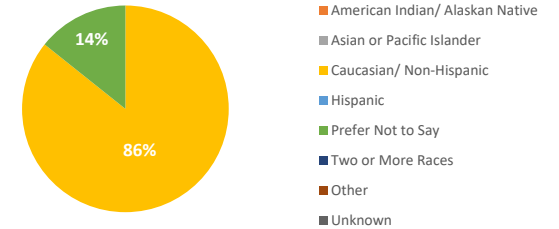
