



ETJ Calls and Statistics (Third Quarter)

Officer and Citizen Generated Calls:

There were 228 officer and citizen initiated calls in the ETJ area during the third quarter. Approximately 228 units and 362 personnel responded to the 228 calls for service. Of the 228 officer and citizen initiated calls, 15 of them were 911 calls, 167 were officer initiated, 45 were called in over the administrative line, and 1 was a walk in. The average on-scene time is 16 minutes.

Special Operations Division Deployment:

During the third quarter, the SRT was not deployed.

Traffic Related Incidents:

Officers conducted 25 traffic stops and 59 vessel stops during the third quarter. There was one vehicle crash that involved a hit and run and was property damage only. There were two crashes that involved property damage and one involved personal injury. There were no DWI's during the third quarter and no fatality crashes.

Community Events:

- Welcome Meeting on ETJ: The Cornelius Police hosted an open house for residents who live in the ETJ. Residents were given an overview of the services the Cornelius Police Department would provide to them.
- Cornelius Outdoor Cinema at Ramsey Creek Park: A movie was shown on an inflatable screen at the park on July 7th
- Vessel Safety Inspection at Blythe Landing: Lake Patrol officers assist the public with ensuring their vessels are safe. Officers hosted this event every month during the third quarter.
- Big Day at the Lake: This annual event is hosted in conjunction with the Big Brother/Big Sister club and takes under privileged children out on the lake.
- National Night Out at Bailey Road Park: This annual event is meant to bring the police department and the community it serves closer together.

Non-Sensitive Special Police Initiatives:

We have a very active traffic unit that conducts seatbelt checks, speed enforcement and monitors our top crash locations. During the third quarter, 21 traffic enforcement numbers were created in the ETJ. Our Lake Patrol is also just as active as our traffic team. The Lake Unit conducted 59 vessel safety checks during the third quarter. July 4th is also a holiday that attracts many boats to the lake. Lake Patrol was active in searching for any violations during the July 4th holiday.

Adult Arrests:

One male was arrested during the third quarter for Boating While Impaired.

Evidence and Property:

Seven pieces of evidence was collected and stored during this time. These items include: glass, a window, a screen, a scale, a fan, a microwave, and a hood. These items were collected from both B&E Residential calls and one Vice Complaint call.
