Good morning.

I wanted to give a bit of context and a summary on this also and would be happy to discuss if that is better.

I am not trying to complain but we have been going through the process for a long time on this portion and are hopeful to get this completed asap as there is a new facility on the site that this road serves which has some higher security standards for manufacturing.

Summary and information:

- Stowe Lane is in both Cabarrus County and Mecklenburg County.
- We started the process in early 2022 to get this work completed.
 - Cabarrus County portion of Stowe Lane (NCDOT Division 10, District 1) was abandoned in August of 2022. (See attached pdf with highlighted portions of pertinent pages.) City of Concord resolution attached also.
 - Mecklenburg County portion of Stowe Lane (NDOT Division 10, District 2) was started shortly after per the email attached from then District Engineer Wendy Taylor. That was the process she wanted. It started the internal department process in June 2022 and was approved in July 2022, excepting information for access to landlocked parcels.
 - Late 2022 and 2023- Worked with County and NCDOT to provide and let them review all deeds for all the parcels, then record an access easement for any landlocked parcels once abandonment was completed. This was recorded in October 2023.
 - Resolution was passed in January 2024, but the County made a mistake putting the incorrect State Route Number on the resolution.
 - We worked with David Goode from February until August to get the new resolution with the correct State Route Number.
 - NCDOT then waited a month to do anything with it, so it missed the December 5th agenda. We are told it will be on the January 7th agenda.
- Team Hendrick Way Cabarrus County Street Name Approval is attached. We have contacted them to change the street name.

All this being said, we understand this is not your issue nor yours to resolve, but want you to understand the urgency is due to a 6-month delay from a County Resolution issue (lack of response by an individual until I emailed the County Clerk to get assistance). Please be understanding if you feel like we are pushing to get this completed.

I also spoke with Stuart Basham (NCDOT Division 10 DM-STIP Program Manager- past Division Engineer) this morning who has helped us on many projects and guidance on issues. He told me that NCDOT does not typically care about street names. I spoke to Stuart because we are getting no response from the District Engineer.

The path for all this seems to be in the right direction since NCDOT already abandoned the northern portion of Stowe Lane in Cabarrus County, so we see no reason they would not follow the same path on the Mecklenburg portion. Cabarrus County and Concord have also already approved and reserved the Team Hendrick Way street name, and we are waiting to change all of them at the same time.
