# **Increase Flu Vaccinations**

- Expanding the number of flu vaccines provided at MCPH clinics and MCPH off-site events
  - Obtaining additional vaccine supply (pending NC DHHS approval)
  - Extending appointment availability (e.g. evening hours and weekend clinics)
  - Flu Fighter Fridays: 10/23, 11/20, 12/4, 12/8
  - *Sleeve Up Saturdays*: 11/14, 12/12
- Partnering with community agencies to provide increased vaccine coverage to priority populations



## **COVID-19 Update**

## Daily COVID-19 Cases Reported to MCPH by Date\*



\*Beginning June 22, case counts were updated using a new reporting function in the state communicable disease management system. These counts include cases reported after the daily cut-off time of 5p.m. This approach ensures case counts are not artificially impacted by delays in lab results and case investigations.

# COVID-19 Testing Update

- COVID-19 testing remains widely available throughout Mecklenburg County
- Turnaround times are stable, with most results being returned in 24 to 48 hours (average 1.3 days)
- MCPH is deploying new testing resources from state and federal partners
  - New mobile, surge and rapid testing capacity
  - Focus on targeted testing among special populations (e.g. high-risk adults, hardest hit neighborhoods, CMS staff/teachers, university students, gatherings, etc.)

# **Testing Guidance**

- COVID-19 testing is recommended for people who have...
  - Symptoms of COVID-19
  - Had close contact with someone who has COVID-19, with and without symptoms
  - Higher risk due to age, other health conditions, or work environment
  - Recently attended <u>any gathering</u>, especially those where COVID-19 safety guidance not adhered to
- Public Health will continue to work with our partners to ensure COVID-19 screening and testing are available to all who need it in our community, regardless of insurance coverage.

# COVID-19 Ambassador Program Update

- COVID-19 Ambassadors (CAs) have completed <u>758</u> compliance inspections and <u>726</u> service requests
  - Most common concerns continue to be mask wearing, social distancing and occupancy limits
- CAs noted improved masking and compliance by locations that had previously been visited and concerns were noted
- Several locations have increased security to assist in monitoring crowds and enforce masking and social distancing
