AWARDS/RECOGNITION

25-0477 NATIONAL SUICIDE PREVENTION WEEK

Background: The purpose of this proclamation is to bring awareness to Suicide Prevention Week and recognizing it as a Global Health Crisis. The goal is to understand that suicide is preventable, but we have to work together as a community, a culture, and a society to stop this crisis. Prevention begins with conversations about mental health, the impact of suicide, and helping connect people with appropriate services.

communities during times of crisis. These caregivers provide more than just shelter; they offer unconditional love, cultural continuity and emotional healing. By acknowledging Kinship Care Month, we commit to raising awareness, advocating for equitable support and celebrating the resilience and compassion of these families. Kinship care is not just a placement - it's a promise: A promise that family will show up, step in and stand strong.

Commissioner Leake read the proclamation.

WHEREAS, nationally more than 2.7 million children are living with grandparents, other relatives, and fictive kin in kinship care of which 85,000 of these young people reside in North Carolina; and

WHEREAS, citizens of Mecklenburg County join to honor children residing in urban, rural, and suburban households in Mecklenburg County who through the unconditional support of their kin, have successfully addressed the emotional trauma of being separated from their parents; and

WHEREAS, the public becomes increasingly aware of the challenges faced by children and their kinship caregivers to work in partnership with the education, legal, social services, mental health, justice and other systems to access services that can enable kinship youth to flourish in all facets of their life; and

Whereas, children will live within a kinship family sometime during their childhood, kinship care provides the best opportunity to retain the child's cultural heritage and community ties.

NOW, THEREFORE, BE IT RESOLVED, that the Mecklenburg Board of County Commissioners hereby proclaims September 2025 as

"NATIONAL KINSHIP CARE MONTH"

in Mecklenburg County and encourages all citizens, community agencies, religious organizations, businesses and others to celebrate kinship families that offer safety, permanency, and well-being for children who are unable to remain with their birth parents.

Background: Medicare for All Act of 2025" provides universal health insurance coverage for quality healthcare (including mental healthcare) including all necessary medical treatment, prescription drugs, women's reproductive care, dental, vision, and long-term care, without copays, deductibles, or other out-of-pocket costs, it also lessens the burden on safety-net healthcare resources and offers the administrative cost savings of a single-payer system.

Commissioner Meier read the resolution.

Motion was made by Commissioner Meier, seconded by Commissioner Leake, and unanimously carried to approve a Resolution in support of the Medicare for All Act of 2025.

Dr. Doug Robinson, Chair of Health Care Justice of North Carolina, Reverend Dr. Jannet Garner Mullins, and Chris Merritt, President of Charlotte Metrolina Labor Council accepted the proclamation and gave remarks.

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF MECKLENBURG COUNTY, NORTH CAROLINA, IN SUPPORT OF THE MEDICARE FOR ALL ACT OF 2025

WHEREAS, every person in Mecklenburg County, NC deserves comprehensive, quality, lifetime healthcare and access to care is not only a major domain of The Social Determinants of Health, but also, a Mecklenburg County Community Health Priority; and

WHEREAS, the most recent estimates from the U.S. Census Bureau indicate that over 130,000 Mecklenburg residents do not have access to health insurance with greater disparities among younger adults, residents of color, and residents with lower incomes or educational attainment; and

WHEREAS, access to health insurance benefits residents by consistently offering preventive healthcare services and reducing the likelihood of severe health challenges that include chronic disease and early or premature death; and

WHEREAS, the lack of health insurance can lead to financial burdens for families or individuals that further negatively affect one's health and increases the likelihood of a family or individuals going into debt to cover the cost of necessary medical care; and

WHEREAS, greater access to health insurance can be associated with positive community-level financial trends such as higher economic growth and lower levels of child poverty; and

WHEREAS, the "Medicare for All Act of 2025" provides universal health insurance coverage for quality healthcare (including mental healthcare) including all necessary medical treatment, prescription drugs, women's reproductive care, dental, vision, and long-term care, without copays, deductibles, or other out-of-pocket costs, it also lessens the burden on safety-net healthcare resources and offers the administrative cost savings of a single-payer system;

NOW, THEREFORE, BE IT RESOLVED, that the Mecklenburg County Board of Commissioners endorses Medicare for All and therefore urges Congress to pass the "Medicare for All Act of 2025" as described in H.R. 3069 and S. 1506 and calls upon our federal representatives to support its prompt enactment, assuring comprehensive and quality healthcare for all residents of the United States.

25-0462 Lake Norman Marine Commission

Background: In accordance with N.C.G.S. § 77-89.3, Mecklenburg County shall appoint two (2) members to the Commission, who:

- Shall be a full-time resident of Mecklenburg County for at least nine (9) months each year;
- Shall serve a five (5)-year term, unless otherwise specified to stagger initial terms;
- Shall meet the ethical requirements and conflict-of-interest standards of N.C.G.S. § 77-89.3(f); and
- May be removed for cause under N.C.G.S. § 143B-13.

Each participating local government shall appoint two members to the Commission, each of whom shall be individuals who have demonstrated proficiency in community engagement and consensus-building across multiple stakeholder groups. For the initial appointments, each participating local government shall appoint one commissioner to serve a four-year term and a second commissioner to serve a five-year term. Except as otherwise provided for the initial appointments, each commissioner shall serve a five-year term.

PUBLIC HEARINGS

25-0466 Business Location and Expansion - TOROMONT USA, INC and AVL USA, INC.

Background: AVL USA, INC. (Job creator) and Toromont USA, INC. (capital investment entity) are entities owned by Toromont Industries, Ltd., a Canadian publicly traded company founded in 1961.

This is the first US-based location for the Equipment Group branch production and assembly of generator enclosures (metal cabinets) for power redundancy.

These are metal casings that include electric inputs and closures required for data center servers and equipment for the data power generation, automotive, automation, construction, emergency management & energy storage sectors.

AVL USA, INC and TOROMONT USA, INC. proposed project meets all the following grant guidelines for a 5-year Business Investment Grant, specifically:

- A taxable investment of \$56,015,800 to be completed during the grant term.
- Creation of 326 new jobs with an average wage of \$76,052 (which is equal to or greater than 100% of the average SOC codes for the jobs stated for the Charlotte-Gastonia-Rock Hill M.S.A.).
- There is competition for this project from Wamego, KS.

The general terms and conditions of this grant include:

- A portion of the grant must be repaid if the company moves this investment from Charlotte within 5 years of the end of the grant term.
- Actual grant payments are based on the value of the investment as appraised by the Mecklenburg County Tax Office.
- All property taxes due from the company must be paid before a grant payment is made.

The Board of County Commissioners indicated its intent to approve this grant in a closed session on 05/20/2025

Motion was made by Commissioner Dunlap, seconded by Commissioner Griffin, and unanimously carried to open the public hearing to receive comments on a proposed Business Investment Program grant to TOROMONT USA, INC. and AVL USA, INC.

There were no speakers for this portion of the agenda.

Motion was made by Commissioner Rodriguez-McDowell, seconded by Commissioner Meier, and unanimously carried to close the public hearing and adopt a resolution approving a Business Investment Program grant to TOROMONT USA, INC. and AVL USA, INC. for a not-to-exceed amount of \$641,506 and authorize the County Manager to negotiate and execute the contract.

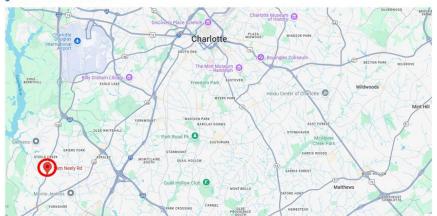

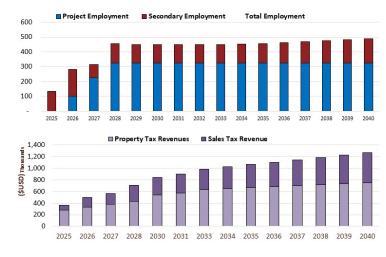

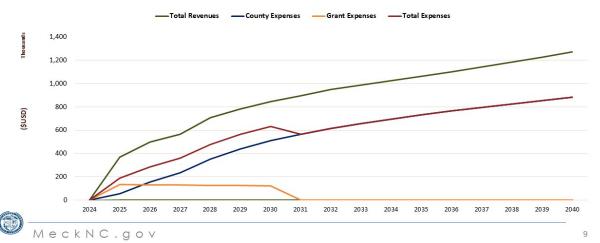

Comments

Commissioner Rodriguez-McDowell said, on behalf of the committee, they unanimously supported it and were excited about the corporate culture it would bring as well as opportunities. She said they were happy with the jobs and different wages as well as positions that did not require a degree.

Commissioner Powell said it seemed there was already a building there. Mr. Clay said there was a brand-new building there, but it was not built for them. He said it was a spec building they would then go into.

Commissioner Townsend-Ingram said they should think about how they leveraged incentives they gave to get what they needed for the community. She asked if there was an opportunity to say if they invested in a transportation fund of childcare for their employees. She said they needed to align the grant program and opportunities with what they needed in the community. *Mr. Andrews said they did look for those opportunities, but they could not do that with every priority.*

Commissioner Leake asked how many jobs they would need from the Steele Creek region. *Mr. Andrews said they were anticipating 326 jobs.*

Commissioner Leake asked if CPCC was available if training was necessary. Mr. Andrews said yes.

MECKLENBURG COUNTY BOARD OF COMMISSIONERS RESOLUTION APPROVING BUSINESS INVESTMENT PROGRAM GRANT FOR CITIGROUP TECHNOLOGY INC.

<u>WHEREAS</u>, Citigroup Technology Inc. is seeking to locate its operations in Mecklenburg County; and

<u>WHEREAS</u> the organization evaluated sites in Jacksonville (FL), Tucson (AZ), Irving (TX), Tampa (FL), and Boise (ID); and

WHEREAS, this project, as described by the company, was determined to meet all of the criteria for a Business Investment Program grant from the County of Mecklenburg, the Board of Commissioners voted its intent to provide a Business Investment Program grant to the company during a closed session meeting on 05/06/2025, and as authorized by the Board, the County communicated this information to the company; and

WHEREAS, taking into consideration the Board's stated intent to make an economic development grant, the company subsequently decided to expand in Mecklenburg County. The project will include a capital investment of \$16,100,000 and will create 510 new jobs within 5 years at an average annual salary of approximately \$133,441. The Business Investment Program grant is a 50% grant over 5 years, with a not-to-exceed amount of \$185,341. The grant will be subject to the County's standard contract provisions, including compliance requirements for the company related to job creation targets and claw-back provisions; and

WHEREAS, Mecklenburg County Board of Commissioners has determined that this grant will provide new employment, new taxable property, and new economic activity within the County, now, therefore, be it

RESOLVED that the Board of County Commissioners does hereby approve the Business Investment Program grant as described above and authorizes the County Manager to execute a contract for the same, with any necessary or helpful nonmaterial changes.

25-0470 Business Location and Expansion - CITIGROUP TECHNOLOGY INC.

Background: CITIGROUP TECHNOLOGY INC. is a subsidiary of Citigroup, Inc., a major multinational banking and financial services company headquartered in New York City. CITIGROUP TECHNOLOGY INC. is focused on providing global technology services for the company's internal

business groups. The company is evaluating designating a new "hub" location in which to expand its technology development and related operations to satisfy the demands of the company's growth.

CITIGROUP TECHNOLOGY, INC. proposed project meets all the following grant guidelines for a 5-year Business Investment Grant (BIP), specifically:

25-0426 Kings Branch Greenway Land Donation

Background: The subject property owner, Blu South Phase V, LLC has proposed to donate Tax Parcel 205-203-65 (+/- 1.226 acres), for future Kings Branch Greenway in the City of Charlotte, required for rezoning purposes. The land is situated in-between I-485 inner and south of E. Westinghouse Boulevard, with both residential and industrial property surrounding. The land is vacant and covered in tree canopy.

The Donation by Blu South Phase V, LLC will allow the County to construct an expansion of the future greenway in this area and provide access for the residents in the new Blu South residential development.

The donation is consistent with Park and Recreation's Greenway Master Plan that calls for the addition of parkland, greenway and open space within the County. It is also consistent with the County's Environmental Leadership Action Plan.

25-0430 Mallard Creek Greenway Land Donation

Background: The subject property owner, CND-VP Brightside, LLC has proposed to donate a portion of Tax Parcel 051-081-27 (+/- 10.18 acres), for future Mallard Creek Greenway in the City of Charlotte's Extraterritorial Jurisdiction, required for rezoning purposes. The land is located adjacent to Mecklenburg County's eastern boundary line, just south of N. Tryon Street with both multi-family and single-family communities surrounding. The land is vacant and mostly treed with a few open fields, along with Mallard creek along the southern property line.

The Donation by CND-VP Brightside, LLC will allow the County to construct an expansion of the future greenway in this area and provide access for the residents in the new Brightside multifamily residential development.

The donation is consistent with Park and Recreation's Greenway Master Plan that calls for the addition of parkland, greenway and open space within the County. It is also consistent with the County's Environmental Leadership Action Plan.

25-0432 Back Creek Greenway Land Donation

Background: The subject property owner, Zora University Owner, LLC has proposed to donate Tax Parcel 105-012-40 (+/- 1.271 acres), for future Back Creek Greenway in the City of Charlotte, required for rezoning purposes. The land is situated east of I-85 and west of E W. T. Harris Boulevard with both multi-family and single-family communities surrounding. The land is vacant and covered in tree canopy with Back creek along the southern property line.

The Donation by Zora University Owner, LLC will allow the County to construct an expansion of the future greenway in this area and provide access for the residents in the Zora University multifamily development.

The donation is consistent with Park and Recreation's Greenway Master Plan that calls for the addition of parkland, greenway and open space within the County. It is also consistent with the County's Environmental Leadership Action Plan.

25-0450 Storm Water Program - Hazard Mitigation Catawba River Floodplain

Background: Since late 1999, Mecklenburg County has used storm water fee revenue to mitigate flood prone property. Buyouts reduce the risk to life and property during floods, while also enhancing the natural and beneficial functions of the floodplain. Mecklenburg County uses the land as open space, to expand greenways, to construct wetlands, etc.

At the November 6, 2024 Mecklenburg Board of County Commissioners (BOCC) meeting, the BOCC adopted the MECKLENBURG COUNTY RESOLUTION ADOPTING GUIDELINES FOR A VOLUNTARY BUYOUT AND RETROFIT GRANT PROGRAM FOR FLOODPLAIN STRUCTURES THAT SUSTAINED FLOOD DAMAGE FROM TROPICAL STORM HELENE ON SEPTEMBER 25, 2024 OR AFTER. The resolution set out guidelines for use of the Storm Water Capital Reserve for voluntary buyouts and retroFIT grants for floodplain structures that sustained flood damage from Tropical Storm Helene. These properties were selected for possible acquisition using criteria listed in the adopted Resolution.

The requested actions will consist of acquiring the property and demolishing the existing home. The purchase price is based upon the pre-flood Fair Market Value (FMV) minus documented flood damages from the September 2024 event. The structure was washed away during the event and was therefore deemed 100% damaged. The owners have voluntarily agreed to sell to the County for the FMV minus Actual Cash Value (ACV) of structural losses (from appraisal using the Cost Approach method) per the November 6, 2024 resolution as outlined in the table below:

Storm Water Services staff allows the Charlotte-Mecklenburg Police Department and the City of Charlotte Fire Department training opportunities for police and fire personnel prior to demolition of flood prone buildings.

25-0452 National Opioids Settlement Agreement with Purdue Pharma

Background: The settlement involves the resolution of legal claims by state and local government against Purdue. All 50 states, the District of Columbia, and four US territories have agreed to the settlement. Local governments are asked to join settlement, contingent upon bankruptcy court approval.

NORTH CAROLINA AND LOCAL GOVERNMENTS ON PROCEEDS RELATING TO THE
SETTLEMENT OF THE OPIOID LITIGATION.

WHEREAS, Mecklenburg County, along with several counties and municipalities in North Carolina, joined with thousands of local governments across the country to file lawsuits against opioid manufacturers and pharmaceutical distribution companies and chain drug stores to hold those companies accountable for their misconduct; and

WHEREAS, the Centers for Disease Control and Prevention has estimated the total economic burden of prescription opioid misuse alone in the United States to be \$78.5 billion dollars per year, including the costs of healthcare, lost productivity, addiction treatment and criminal justice involvement. More than 41,500 North Carolinians lost their lives to a drug overdose from 2000-2023; and

WHEREAS, a settlement has been reached with Purdue Pharma L.P and the Sackler family in the amount of \$7.4 billion dollars related to its role in the opioid crisis; and

WHEREAS, settlements (collectively "the Secondary Opioid Manufacturer Settlements") have been reached in litigation against Alvogen, Inc., Amneal Pharmaceuticals LLC, Apotex Corp., Hikma Pharmaceutical USA Inc. f/k/a West-Ward Pharmaceutical Corp., Indivior Inc., Sun Pharmaceutical Industries, Inc., Viatris Inc., and Zydus Pharmaceutical (USA) Inc., as well as their subsidiaries, affiliates, officers, and directors (collectively "the Secondary Opioid Manufacturer Defendants") named in the Secondary Opioid Manufacturer settlements; and

WHEREAS, representatives of local North Carolina governments, the North Carolina Association of County Commissioners, and the North Carolina Department of Justice have negotiated and prepared a Third Supplemental Agreement for Additional Funds ("SAAF-3") to provide for the equitable distribution of the proceeds of the Secondary Opioid Manufacturer Settlements. Local governments are asked to join the settlement, contingent upon bankruptcy court approval; and

WHEREAS, it is advantageous to all North Carolinians for local governments, including Mecklenburg County to sign onto the Secondary Opioid Manufacturer Settlements, SAAF-3, and approving the bankruptcy plan and settlements relating to Purdue and the Sackler family, in order to demonstrate solidarity in response to the opioid overdose crisis and to maximize the share of settlement funds received both in the state and Mecklenburg County

to help abate the harm. North Carolina is expected to receive approximately \$150 million from the Purdue Pharma and Sackler family settlement; and

WHEREAS, eighty-five percent (85%) of the funds will go directly to counties and eligible municipalities to be used for opioid remediation, such as addiction treatment, recovery services, and harm reduction initiatives. The remaining 15% will go to the state for broader opioid-related programs.

NOW, THEREFORE BE IT RESOLVED, Mecklenburg County hereby continues to authorize ongoing participation in settlement recommendations and authorizes the County Manager or County Attorney to execute any and all documents on behalf of Mecklenburg County necessary to participate in the ongoing settlements with the Secondary Opioid Manufacturer Defendants, to execute the SAAF-3, and to approve the bankruptcy plan and settlement agreements relating to Purdue and the Sackler family and to provide such documents to Rubris, the Implementation Administrator, as recommended.

25-0433 Temporary Construction Easement - Hoover Creek Greenway

Motion was made by Commissioner Leake, seconded by Commissioner Dunlap, and unanimously carried, to authorize the County Manager to grant a Temporary Construction Easement of approximately \pm 0.1234 acres or 5,375 square feet to Steele Creek Owner, LLC on Mecklenburg County owned tax parcel 219-124-22 for the construction of a retaining wall.

Background: At its June 17, 2025, meeting, the Board approved to accept a donation of \pm 1.6101 acres of land on a portion of tax parcels 219-121-14 and 219-124-01 from Christ the King Lutheran Church for future Hoover Creek Greenway and for a new residential community development as a rezoning requirement by petition 2023-164.

Steele Creek Owner, LLC ("Steele") is developing a 187-unit townhome residential community. Steele is planning to construct a retaining wall to serve the development. Steele is requesting ± 0.1234 acres or 5,375 square feet of Temporary Construction Easement (TCE) to access a portion of Mecklenburg County property (tax parcel 219-124-22) located along Hoover Creek Greenway at the undeveloped Generations Street Park to complete grading activities associated with this work.

The TCE will commence upon the effective date of the Agreement and will expire in twelve (12) months. Steele will be responsible for restoring the TCE area to the same or improved condition. Steele inadvertently proceeded with donating parcels to the County instead of customarily holding the parcels to use for staging during construction. The value of the two (2) parcels the County received exceeds the value of the TCE area, therefore, the County will not receive cash compensation.

The request has been reviewed by the Park and Recreation Department and it has been determined that the request will not negatively impact the park property.

25-0451 Grant application - U.S. Department of Justice's Office for Victims of

Motion was made by Commissioner Leake, seconded by Commissioner Dunlap, and unanimously carried, to affirm the submission of an application to fund essential services and case management for victims of elder abuse, fraud, and exploitation in the amount of \$375,000; and, if awarded, recognize, receive and appropriate amount awarded to the General Grant Funds (G001) under Child, Family & Adult Services; and adopt the required grant project ordinance for the Victims of Crime Act grant in the General Grant Fund (G001).

Background: The Mecklenburg County Department of Child, Family & Adult Services (CFAS) - Services for Adults (SFA) seeks affirmation of its submission of a grant application to the U.S. Department of Justice's Office for Victims of Crime (OVC) for funding under the FY25 Services for Victims of Crime program. This application requests \$375,000 over a 36-month term - beginning October 1, 2025, and concluding September 30, 2028 - with no match required.

The proposed funding will support:

- Essential Services (\$100,000/year): Provision of emergency housing, clothing, food, medical equipment, medications, furniture, day programs, and other critical needs for victims of elder abuse, fraud, and exploitation. These services are aimed at promoting recovery, reducing abuse recidivism, supporting aging in place, and decreasing the need for higher levels of care.
- Case Management Services (\$25,000/year): Funding additional services performed by Generations Family Services (GFS) to assist referred adults who require interventions beyond current levels, potentially preventing the need for formal guardianship or Adult Protective Services (APS) involvement. These services include connection to resources, benefit applications, and navigation of care systems.

Due to a compressed federal grant timeline - with the notice released July 21, 2025, and a submission deadline of August 20, 2025, staff were unable to meet the agenda schedule for August 6, 2025. As such, CFAS requests Board affirmation of the submission retroactively. If not affirmed, the application will be withdrawn.

GRANT PROJECT ORDINANCE

WHEREAS, Mecklenburg County has applied for a grant from the U.S. Department of Justice's Office for Victims of Crime up to the amount of \$375,000.00; and

WHEREAS, the grant funds must be used to support services for victims of elder abuse, fraud, and exploitation.

WHEREAS, the Mecklenburg County Board of County Commissioners deems this activity to be a worthy and desirable undertaking.

NOW, THEREFORE, PURSUANT TO N.C.G.S. 159-13.2, BE IT ORDAINED BY THE MECKLENBURG COUNTY BOARD OF COUNTY COMMISSIONERS that:

- Section 1. The project described in the U.S. Department of Justice Office for Victims of Crime (OVC), FY25 Services for Victims of Crime grant application is hereby authorized to be undertaken for the duration of the grant.
- Section 2. The County Manager is authorized to execute the grant agreement and other documents that are required or appropriate for the County to receive the OVC FY25 Services for Victims of Crime and to undertake the project. The County Manager is directed to take steps necessary to ensure compliance with all spending and reporting requirements.
- Section 3. The following revenues are anticipated for Mecklenburg County in the G001 to complete this project:

United States Department of Justice, Office for Victims of Crime \$375,000.00

Section 4. The following amount is appropriated for Mecklenburg County in fund G001 to complete this project:

\$375,000.00

25-0455 Public hearing request on organizing a Metropolitan Public Transportation

Motion was made by Commissioner Leake, seconded by Commissioner Altman, and unanimously carried, to set a public hearing for September 16, 2025, to hear comments from the public and vote on whether to authorize organization of a MPTA and to direct the Clerk to the Board to give notice of the public hearing not less than ten days before the scheduled hearing date, which notice shall contain a brief statement of the substance of the proposed resolution, shall set forth

the proposed Articles of Incorporation of the Authority, and shall state the time and place the public hearing to be held thereof.

Background: The Board of County Commissioners held a public hearing on August 6, 2025 and voted to direct the director of the Mecklenburg County Board of Elections to add an advisory referendum question to the November 4, 2025 ballot on whether to approve an additional one percent (1%) local sales and use tax, in addition to the current local sales and use taxes, to be used only for roadway systems and public transportation systems. If the referendum is approved by the voters, the County may not levy the local sales and use tax under the PAVE Act until it has established a Metropolitan Public Transportation Authority. Further, the PAVE Act requires that certain actions be taken by the MPTA by January 1st, 2026. The legislation authorizes the Board of Commissioners to adopt a resolution signifying its determination to organize an authority under the provisions of the PAVE Act. The resolution shall be adopted after a public hearing thereon, notice of which shall be given by publication at least once, not less than 10 days prior to the date fixed for such hearing.

25-0468 Capital Reserve Request. for Mecklenburg County Sportsplex Synthetic Turf

Motion was made by Commissioner Leake, seconded by Commissioner Dunlap, and unanimously carried, to appropriate \$750,000 in available funds from the Synthetic Turf Capital Reserve Fund (9002) to complete Phase II of synthetic turf renovation at the Mecklenburg County Sportsplex.

Background: Capital Reserve accounts were established to provide funding to maintain synthetic turf fields. Mecklenburg County Sportsplex has four (4) synthetic turf fields that have reached the end of their life expectancy. The fields opened in 2017. General repair is needed to the safety features surrounding these fields. Completing all projects at the same time, while the fields are closed, limits the impact to the customer. Renovation will include replacement of four (4) synthetic turf fields at Mecklenburg County Sportsplex, replacement of safety netting and fencing and new soccer goals.

25-0480 Budget Amendment - Knights Baseball, LLC

Motion was made by Commissioner Leake, seconded by Commissioner Powell, and unanimously carried, to amend the Budget Ordinance for Fiscal Year 2026 to allocated \$2,492,659 of available fund balance to pay off the balance of the existing Economic Development agreement with Knights Baseball, LLC.

Background: On November 20, 2007, the County entered into an Economic Development Agreement with Knights Baseball LLC for the development of the Knights Stadium. The agreement provides Knights Baseball LLC with an amount equivalent to \$8 million at net-present value over 20 years using a discount rate of 8.25%, which equates to \$16,600,700 based on payments of \$830,035 a year.

The Office of Economic Development, Finance, and the Office of Management and Budget have reviewed the contract and determined that it is in the best interest of the County to pay off the remaining balance of the agreement. The balance has been confirmed by Knights Baseball, LLC to be \$2,492,659. Paying off the agreement now will save the county \$5,807,691 (expressed in current value) and eliminate the 10 remaining annual payments of \$830,035.
