In order to do it all together they would have to submit the packages to D1 and D2 at the same time AND D1 and D2 will need to submit our packages to the Division at the same time. I think this may be difficult to do, so I would recommend they abandon the Cabarrus portion first and then we abandon the Mecklenburg section. Just so we can make sure we don't cut off their access. They will need a resolution from Mecklenburg County. The resolution will need to include the SR # and have the exact same mileage that's on our GIS map. He will need to contact David Goode to start this process. His contact info is attached.
