Project Description: The Mecklenburg County Courthouse – Security Improvements & HVAC Controls Upgrades project is anticipated to consist of a full replacement of all original security systems and HVAC Controls throughout the facility. Key components of the project include, but are not limited to the following:

Security System Replacement

- This project will include demolition and replacement of the Access Control, Security & Video Surveillance Systems, and their related components. The existing system was installed by Stanley Security Solutions and was completed in 2004.
- The existing security system is a fully integrated PLC system utilizing analog video systems, access control, and physical security systems that are monitored in a Security Command Center on the basement level.
- The Video Management system utilizes analog cameras and recorders with coax cabling. There is on site video storage using VCR's located on the basement level. Replacement and addition of new security cameras throughout the facility.
- The access control system is comprised of magnetic card readers without encryption managed by an on site computer.
- The facility utilizes door position sensors, door locking release and management for movement throughout the secured areas of the facility. Some areas of the building utilize motion detection, intercom, panic buttons, gate position switches, and a wireless duress system for security monitoring of particular areas. The video system is integrated with security system for intercom / video callup and camera callup for duress locations.

HVAC Controls Replacement

- The existing digital HVAC Controls system is comprised of multiple outdated equipment level controllers. In addition, the HVAC Controls system, in its current configuration, cannot be integrated into the County's HVAC Controls Supervisor for single point management and extended history trending, in conformance with the current HVAC Controls strategy.
- The project shall remove the existing HVAC Control system throughout the entire building and install a new, Tridium based, code compliant HVAC Controls system for all HVAC equipment in all mechanical spaces throughout the building including roof and basement. The new HVAC Controls will include all building and equipment level controllers, temperature sensors, humidity sensors, CO@ sensors, flow switches, current sensors, water temperature sensors, damper actuators, pressure sensors, relays, electric KW meter(s), gas meter(s), etc.

Other Related Scope / Information

- Replacement of all pneumatic controlled smoke dampers throughout the facility.
- Electrical and low voltage / structured cabling work to support the installation and replacement of smoke dampers, security, and HVAC Controls.
- Fire alarm work to support the installation and replacement of smoke dampers, security, and HVAC Controls.
- General trades and architectural work to support the installation and replacement of smoke dampers, security, and HVAC Controls.
- All work will be completed in a phased approach and will require off hours / weekend work as facility will remain in operation during installation of new systems.
- Employee / trade access to facility may likely require background checks and daily ID badging at security station for all employees to gain access to the building.

MWBE Inclusion Plan: The established participation goals for this project are **15% MBE** and **8% WBE**. To meet and exceed this goal the following approach will be implemented during preconstruction:

- Community outreach sessions will be conducted to build relationships, answer questions, and gather information related to the capacity of MWBE firms and to connect minority trades with majority trades.
- Bid packages will be broken down based on the capabilities and availability of MWBE firms.
- Develop strategic partnerships with local minority organizations.
- Offer early pay programs to keep cash flowing or develop bi-weekly payment options and joint check opportunities to major suppliers.
- Hold detailed pre-bid meetings to answer any questions related to the project scope and bid process.
- Hold compliance workshops that will assist firms through our Subcontractor Management System (SMS).

Notice of Decision: All firms that submitted applications for prequalification shall be promptly notified of the Prequalification Committee's decision, including the reason for denial, via email. Notice shall be provided prior to the opening of bids for the project and with sufficient time for the firm to appeal the decision of the Committee.

Appeals: A firm may appeal the denial of prequalification based on G.S. 143-135.8 (b) (2). After a written appeal is received, the Prequalification Committee will rule on the appeal and notify the company of their ruling within three business days.
