Purpose

Acting under the authority delegated by the Mecklenburg County Board of Commissioners the Criminal Justice Citizen's Advisory Committee shall:

- Promote collaboration/coordination across all components of the Mecklenburg County criminal justice system.
- Seek and explore methods of improvement for all aspects of the criminal justice system.
- Review the nature, scope and critical issues associated with the criminal justice system.
- Review the performance of the criminal justice system.
- Respond to Board of County Commissioners and staff requests for advice on matters related to the comprehensive criminal justice system in Mecklenburg County.
- Present the Board of County Commissioners with an annual report of key actions and issues.

Qualifications

The membership of the Charlotte-Mecklenburg Criminal Justice Citizen's Advisory Committee shall include representatives from the following categories:

A resident from each County Commission District within Mecklenburg County (District 1-6) - Six Total Members

A person appointed by the Mecklenburg County Manager acting in association with the General Manager responsible for criminal justice related activities (MGR). - One Member See attached.

The Mecklenburg County Bar (BAR) (Recommended by the Criminal Justice Section of the Mecklenburg County Bar) - One Member

Law Enforcement (LAWE) - One Member

The Charlotte-Mecklenburg School System (CMS) - One Member

A Substance Abuse Professional (SAP) (e.g., A licensed social worker or psychologist) - One Member

A member of the faith community (FAITH) - One Member

A person who has been rehabilitated, but gone through the Mecklenburg County criminal justice system. (REHAB) (The individual should be proposed for consideration by The Center for Community Transitions) - One Member

Must be a resident of Mecklenburg County.

Special Notes

Five (5) appointments for three-year terms expiring May 31, 2015 (Districts 1, 2, 3, 4 and 5). Alan Adler (Dist 1), Dennis Brown (Dist 3), James Henry (Dist 2) and Beverly Moss (Dist 4) are all eligible for reappointment. The Board can nominate and appoint the one eligible applicant, Lawrence Wingate (Dist 5).

Staff will continue to advertise for the remaining vacancies: District 6, Faith Community, CMS Representative and Substance Abuse Professional.
