Methodology


- Workload indicators

 - Calls for service
 - Service time
- Geography
 - ETJs on perimeter of county
- Population - 57,500
 - Comparison Sheriffs' Office staffing
 - Collected data from other agencies

Recruiting and Hiring

- Need Patrol-experienced deputies
- Need deputies with specialized experience/training
- Limited pool of candidates
- Limited timeline

Training

- Sworn – 2,424 total hours
 - BLET (January)
 - MCSO specific
 - Specialized unit specific
- Non-Sworn
 - MCSO specific
 - Specialized unit specific



Milestones for Implementation

- **Approval/funding no later than September 30, 2017**
- Hire/promote command and supervisors 30 days
- Recruit/hire Patrol deputies
 - From current staff Complete 30-60 days
 - Out-of-state hires Complete December 2017
 - In-state hires Complete October 2017-January 2018
- Facilities acquisition Begin immediately
 - Project manager
 - Site locations
 - Leasing/upfit



Milestones for Implementation

- Patrol deployment Begin immediately
 - Develop district boundaries
 - Need data
 - CAD/911 install
- Contract services Begin immediately
 - Communications/911
 - Crime Lab
 - Animal Care and Control
- Hire experienced non-sworn staff for specialized units Spring 2018
- Train new hires January-June 2018

Costs

First-Year Costs
\$21.1 million

Second-Year Costs
\$11.5 million

\$9.6 million capital and
expenses
\$11.5 million annual on-
going costs



First-Year Costs \$21.1 Million

- Personnel \$10.5 million
- Uniforms/Equipment \$ 1.3 million
- Vehicles \$ 4.3 million
- Facilities/Equipment \$ 5.0 million

Second-Year Costs \$11.5 Million

- Personnel \$9.75 million
- Uniforms/Equipment \$284K
- Facilities/Equipment \$1.445 million

Bottom Line

- Sheriff provides policing services in 98 of 100 counties in North Carolina.
- Solid base to build upon. MCSO deputies work throughout the county now.
- Goal of improving service levels to ETJs by deploying deputies dedicated to those areas.
- Work must begin no later than September 30.
