Appointments are made for three-year terms with no one serving more than two full consecutive terms. The Chairman and Vice-Chairman are designated by the Board of County Commissioners.

Qualifications

To qualify for appointment as a member, each nominee to the Board shall be of good moral character, shall have resided in Mecklenburg County at least two (2) consecutive years prior to the appointment, shall remain as a resident for the duration of service as a member, shall be knowledgeable of real estate or personal property valuation matters, and shall not have been convicted of a felony.

Special Notes

NOMINATIONS NEEDED FOR:

- 1) One (1) appointment to fill an unexpired term expiring April 16, 2020
- 2) One (1) appointment for a three-year term expiring April 16, 2021
- 3) This is one of several boards that require an interview process conducted by an ad hoc committee of the Board, with the exception of persons being reappointed. This is one of the seven advisory boards that receive compensation. The Board of Equalization and Review Chairperson receives \$125/meeting and Members receive \$100/meeting. Overtime is \$15 per hour after the initial three-hour period. See attached list of other compensated boards.
- 4) Select Four (4) Board members to serve on the Ad Hoc Committee.
