#### **TEACHING EXPERIENCE**

#### **HS 321 Introduction to Human Services**

#### Wingate University, In-person

An exploration of human service delivery systems; a survey of the field and clarification of vocational choice. In this course, students will learn what it means to be a human service professional. This course explores the themes and purposes of human services, models of service delivery, the client, the human service professional, and the helping process, and how to work within an agency environment.

# HS 323 Professional Counseling and Case Management Skills Wingate University, In-person

This course is designed to strengthen students' understanding of applicable behavioral theories and foundational skills to successfully work as human services professionals in a broad range of settings. Students examine various theories useful in professional interactions with clients.

# SOC 475 Group and Community Work in Human Services Wingate University, In-person

This course is designed to strengthen students' understanding of applicable theories and foundational skills to successfully work as human services professionals in community mental health settings with groups, organizations, and communities. Students examine various theories and relevant skills for different phases of work with each type of client system. A heavy emphasis is placed on practicing these skills through classroom exercises and group projects.

#### **HS 411 Human Services Practicum**

#### Wingate University, In-person

Field experience under supervision of experienced practitioners. Assessment and development of skills and strengths. Capstone course for the major.

#### **HS 475 Community Counseling and Work**

### Wingate University, In-person

This course aims to understand the mental health issues pervasive across borders, along with their psychological prevention and treatment from a community intervention perspective. Students also examine a variety of issues involved in the provision of community-based services such as ethical and legal issues, quality and continuity of care, health disparities, cultural competency, organizational and financial factors, and other relevant policy and practice issues.

Students will examine linkages between community-based services and the advancement of human rights and social and economic justice for persons with mental illnesses and substance use disorders.

# SOWK 131 Introduction to Social Work and Social Justice University of the Cumberlands, Online

An introduction to the many current social work-related issues facing the United States and the world today. The history of the social work field and the roles that professionals play are introduced to assist students with personal career exploration and professional growth. Social justice involves individual as well as social transformation; students will be introduced to different ways individuals experience diversity, oppression, and privilege.

# SOWK 336 Social Work Administration University of the Cumberlands, Online

Provides an overview of Human Services Administration as a profession. The course will examine the roles and functions of Human Services workers/administrators related to managing budgets, monitoring expenditures, planning, evaluating, and other current issues related to human services. The ethical principles that guide the Human Services Administration profession will also be examined.

## **SOWK 436 Human Diversity**

#### University of the Cumberlands, Online

Designed to teach students about the systems that maintain differential access to power and privilege at the expense of the marginalized, skills for understanding and evaluating their own values and belief system, and ways to advocate for the human services' core value of social justice. Ethical decision-making, understanding and applying ethical codes and laws, and opportunities to develop critical thinking skills will also be emphasized and practiced throughout the course.

#### **HSE 410 Case Management**

#### Southern New Hampshire University, Online

Topics covered in this course will include client engagement, interviewing, models of service delivery, ethics and professional responsibility, group dynamics and facilitation, boundaries, and formal/informal client-centered support systems.

#### **HSE 101 Introduction to Human Services**

#### **Southern New Hampshire University, Online**

This course provides an overview of the historical development of human services and an introduction to the many settings, roles, and functions of the human services professional.

Explore the continuum of care model and best practices in substance use disorders, including early intervention, prevention, treatment, and recovery services. Develop a novice knowledge base of community resources to support each component of the continuum.

# HSE 352 Substance Use: Counseling Theory and Practice Southern New Hampshire University, Online

Examine a variety of theoretical approaches with a focus on evidence-based counseling techniques widely used in Substance Use Disorder treatment. Practice ethical and culturally sensitive documentation skills to record individual and group therapy progress notes.
