Purpose

The committee reviews, makes recommendations and provides input into short-range transit operations. The TSAC focuses on day-to-day operations of the transit service to ensure that it meets the needs of the community. TSAC makes recommendations to the Metropolitan Transit Commission (MTC) on issues within its sphere of interest, and acts as a vehicle to promote public involvement in short-term transit planning. The committee serves as a forum for citizen suggestions and complaints concerning fares, routes, and schedules. It also serves as an advocacy group for public transportation services and reviews staff recommendations on services provision and transit policies. The TSAC reviews and makes recommendations on minimum performance standards for the system. The TSAC also explores emerging issues in public transit and works with staff on solutions.
