Dear Chairman Dunlap:

We are writing to share our recommendation for a new Charlotte Mecklenburg Library Board Trustee in preparation for actions by the Board of County Commissioners at your upcoming meetings in May and June.

The new appointee will fill Dr. Ellen McIntyre's unexpired first term. Dr. McIntyre recently relocated to Knoxville, Tennessee to become the Dean of the College of Education, Health, and Human Sciences at the University of Tennessee.

The Library CEO, Board of Trustees Chair, and Nominating Committee Chair annually review the Board's composition with an eye on five things --- (1) depth and breadth of engagement; (2) skills, knowledge, and experiences; (3) leadership potential; (4) diversity of all types; and (5) strategic priorities, to ensure that the Library's governing body has the capacity and capabilities to guide the organization while serving the entire community.

New Library Trustee Recommendation

On behalf of the Library Board, and based on the organization's identified volunteer leadership needs, we recommend community member Amy Hawn Nelson for appointment to the Board effective July 1, 2020.

A graduate of Charlotte-Mecklenburg Schools and UNCC, Amy Hawn Nelson is a community-engaged researcher focusing on topics related to educational equity and policy. Before joining the Research Faculty at the University of Pennsylvania, Amy served as the Director of Social Research for the UNC Charlotte Urban Institute and Director of the Institute for Social Capital. She was named Charlottean of the Year in 2015 largely due to her research and community engagement around issues of educational equity.

In addition to her research, Amy brings a strong educational background, having served as a teacher and school leader for 11 years. She also served on the Library's Strategic Planning Steering Group in 2013 and added valuable insights and contributions. Amy and her husband have 2 young daughters and live in Charlotte/District 4.

Amy brings experience and depth in public education to replace what our Board lost when Dr. Ellen McIntyre relocated. She understands the important role our libraries play in Charlotte-Mecklenburg and is very enthusiastic about contributing her talents and serving in this role. She has applied for the position online and has agreed to serve on the Library Board of Trustees if appointed.

Board Mix

As a very public institution serving all of Mecklenburg County, the responsibility of reflecting the people and voices of our community is taken seriously. The addition of Amy Hawn Nelson would maintain the demographic mix of our Board of Trustees at its current level. Please also see attachment of current Trustees.
