NOTICE OF PUBLIC HEARING

The Mecklenburg County Board of Commissioners will hold a public hearing on Thursday, May 23, 2024 at 6:00 p.m. in the Meeting Chamber of the Charlotte-Mecklenburg Government Center (CMGC) located at 600 East Fourth Street, Charlotte, NC, to receive public input as part of the Fiscal Year 2024-2025 budget process.

Concomitant with and following the public hearing on the proposed FY 2024-2025 budget, the Board of County Commissioners will also hold public hearings to receive public comments on the following fee adjustments: proposed adjustments to permitting and compliance monitoring fees by Mecklenburg County Air Quality found in MCAPCO Regulation 1.5231 - "Air Quality Fees."; AND proposed revision to the County and Towns' Land Development services fees (excluding Huntersville); AND proposed amendment to the County's Major System component of the Storm Water fee; AND proposed amendments to the City of Charlotte's Minor System component of the Storm Water fee.

Additional information can be found at www.charmeck.org/stormwater. The public hearing by the Board of County Commissioners is in accordance with the provisions of the "AGREEMENT FOR THE OPERATION OF A SINGLE STORM WATER SYSTEM IN MECKLENBURG COUNTY."

The deadline for online registration is May 22, 2024, at 5:00 p.m. After the online registration has closed, members of the public may still register to speak when they arrive at the meeting on May 23, 2024. You are encouraged to sign up in advance, otherwise, your name will be placed at the end of the already existing list of speakers. Information will be provided to speakers on the day of the meeting for those who have signed up to attend.

Time Allotment: An organization represented by one or two persons or an individual representing him or herself is allowed three (3) minutes each to speak. Each organization is allowed no more than four (4) speakers with a time allotment of ten (10) minutes total for the group. NOTE: The Board reserves the right to alter these rules on a case-by-case basis as necessary for the efficient and effective conduct of business.

As an alternative to addressing the Board, the Clerk to the Board will also accept written comments on the proposed FY2025 budget. All comments will be compiled and submitted to the Board of County Commissioners at the Budget Public Hearing. Comments will be archived with the permanent meeting files. Please note, all information provided in comments are subject to the NC Public Records Law and will be released upon request. Comments may be submitted via email to clerk@mecknc.gov or mail to the Clerk to the Board, Charlotte-Mecklenburg Government Center, 600 East Fourth Street, 11th Floor, Charlotte, NC 28202. All comments must be received by Wednesday, May 22, 2024, at 12:00 p.m.

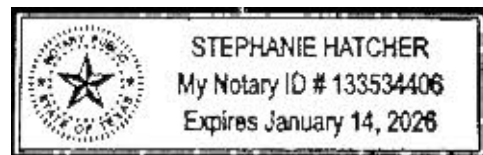
