The past two years of my professional life has involved community and worker advocacy throughout Charlotte. The untimely death of fallen operator, Ethan Rivera, caused me to answer the 'clarion call' that rang ever so loudly across the city, 'I could not ignore'. Safety is a key element in the successful operation of any community. When workers, operators are shot and killed on the job, I do not feel the city has a right to rest until the workers and streets are safe for our public servants. THIS IS NOT ACCEPTABLE, and a change must take place! Over the past three years, as a former resident in the Cherry Community, I organized the Cherry Community Connection Cookout which was an effort to bridge the gap between the old and new neighbors of Cherry. The economic wealth gap was an eyesore to the original Cherry residents. I organized the event as an effort to identify ways to strengthen the ties within the neighborhood. The change and growth had already taken place, our messaging was, it would be a benefit to the community as a whole to find common ground. We successfully did that for the three years the event was held. There were some deep lasting relationships that were built which carries my work still today in the area. My civic responsibilities are most important to me and it is a role I do not take lightly. A great work has begun, and I look forward to the opportunity to continue it, if granted. As a project manager, I understand the importance of time management, risks and opportunities. My role often times leads me to operate in a role where I am supporting leadership development of workers and handraisers of the community. The position often times calls for statewide strategy implementations and analysis of the outcome. However, working closely with the community is the main priority I hold when approaching any assignment. Once an organization understands the needs of the people they serve, ensuring they always hold space in room they may not physically be in is and always will be a focus of mine.

It has been said I am like a magnet, people are magnetized towards me; It is undoubtedly true. I absolutely love being in community with others, especially when the interaction is progressive and producing sustainable solutions. As a communications major, moving and working the room is what I do effortlessly. I consider myself the great communicator, one who is able to hear the words that are never spoken. It affords me the ability to hear the important missing pieces of the conversation. As an activist/ advocate, I often tell people this isn't paper and plastic this is purpose and passion. I am a Charlottean born and raised, graduate of Myers Park High School. My city means the world to me and I look forward to serving my city in one capacity or another. The safety of the commuters and operators is directly related to housing, economic equality and other categories that are impacted when the residents can't arrive safely to their employer. Saying that, I have been involved in the labor movement for over five years now, and I have held hundreds of conversations with people. Once someone masters effective communication, the possibilities are endless; I have done just that. Thankfully, I am able to speak with anyone, at any given time, and talk about mostly anything. It is an effective organizing skill and I use it to the fullest everyday. Charlotte has changed tremendously in the past 20 years. I grew up in Southside homes, riding the city bus almost everyday; route#16 South Tryon. What happens on the buses, at the bus stops, concerns me. If it weren't for public transportation, I am not where I am. What commuters are facing today onboard isn't what I endured years ago. Every rider deserves a safe ride. If someone pays their fare, then we have an obligation and duty to care. The bus stops throughout the city need dire attention and some are unsafe for our elderly population. As a former caregiver, they hold a special place in my heart and we must ensure they are taken care of during their golden season and feel safe while maintaining their independence. Project management, former UPSER and CATS Operator, activist and advocate, civil servant and passionate native of Charlotte, I bring a wide variety of skills and expertise to this space. I also bring a spirit of openness to learning new things. As a veteran in the United States Army, my interest in transportation began there as a 88M. It was there I established convoy knowledge, tactical support, logistical planning and various management tools that I still commonly practice today. It would be a honor to serve, I do however, bring a wealth of knowledge to this space.

The community knows my face, they trust what I do and why I do it. And that makes me want to continue the work ensuring the people who trust me are safe during their day to day.

The Public Transit Advisory Committee (PTAC) was established by the Metropolitan Transit Commission (MTC) effective January 1, 2025, through an interlocal agreement between the City of Charlotte, Mecklenburg County and the six towns. PTAC replaces the Citizens Transit Advisory Group (CTAG) and the Transit Services Advisory Committee (TSAC).

PTAC is responsible for (1) reviewing the CATS CEO's proposed operating programs and five-year capital programs, (2) reviewing transit policies, (3) serving as an initial forum for suggestions and complaints concerning fares, routes, and schedules, and (4) making recommendations to the MTC regarding these matters. PTAC shall also be responsible for providing such other advisory functions as directed by the MTC.

15 members* (one Co-Chair appointed by the Mayor and one Co-Chair appointed by the Chairperson of the Mecklenburg County Board of Commissioners, two members appointed by City Council, two members appointed by the Mecklenburg Board of County Commissioners, one member appointed by the Charlotte-Mecklenburg Board of Education, one member appointed by the towns of Cornelius, Davidson, Huntersville, Matthews, Mint Hill and Pineville, and two at-large members* appointed by the MTC, one of which shall be a person with a disability and one shall be a fixed route service rider). * At their November 20, 2024, meeting, the MTC voted to add the two at-large appointments.

- A publicly elected office holder shall not serve on PTAC.
- An additional member may be appointed by a regional member pursuant to Section IV, A. of the Interlocal Agreement (if any).
- Appointees should be residents of Mecklenburg County.
- Consideration will be given to riders of public transit.
- All appointees are subject to the MTC's Rules of Procedure. To ensure stability and continuity, the members of the PTAC shall serve three-year staggered terms that begin on January 1 and end on December 31. The initial terms of the appointees of the Mecklenburg County Board of Commissioners, the Charlotte City Council, The Charlotte-Mecklenburg Board of Education, and the Mayor of the City of Charlotte shall end on December 31, 2026. The initial terms of the appointees of the Towns and the Chairman of the Mecklenburg County Board of Commissioners shall end on December 31, 2027. Terms shall be for three years, after the initial term, and any term limits shall be in the discretion of the member's appointing authority.
