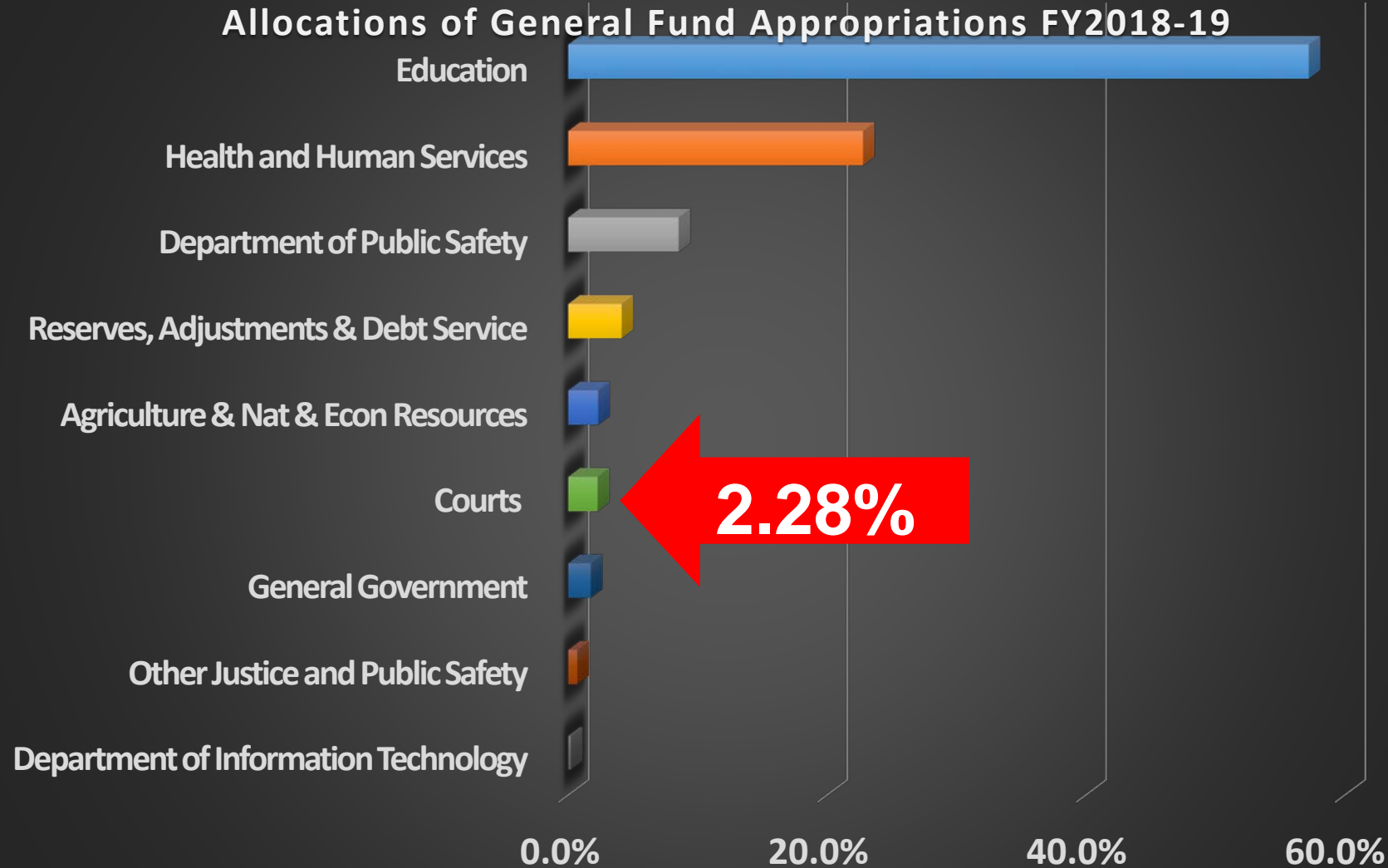

Magistrates

- Responsibilities:
 - Initial appearances
 - Pretrial release determinations
 - Arrest warrants
 - Search warrants
 - Accepting guilty plea in minor misdemeanor and infraction cases
 - Marriage ceremonies
 - Small Claims cases
 - Commitment hearings
 - Payments to satisfy court orders
 - Administrative creation of court and district attorney paperwork



Magistrates

- Mecklenburg County has 34 Magistrates
- According to Administrative Office of the Courts, we are understaffed:

Magistrates Need Based on Filings through 6/30/2017

County	Magistrates Authorized 7/1/2017	Unrounded Magistrates Needed	Staff to Workload Ratio
Mecklenburg	33.5	52.58	64%



Magistrates

- **Requesting:**

- 5 Magistrates**

- 24 Hour Coverage
 - 40 Hour Shifts
 - To meet increased population growth in North Mecklenburg County
 - Collaboration with County and Northern towns



Magistrates

- **Considerations:**
 - Victim Data for northern cities/towns is unknown
 - Staffing
 - Paperwork and Money pick up
 - Technology Access- NCAWARE
 - Safe Alliance



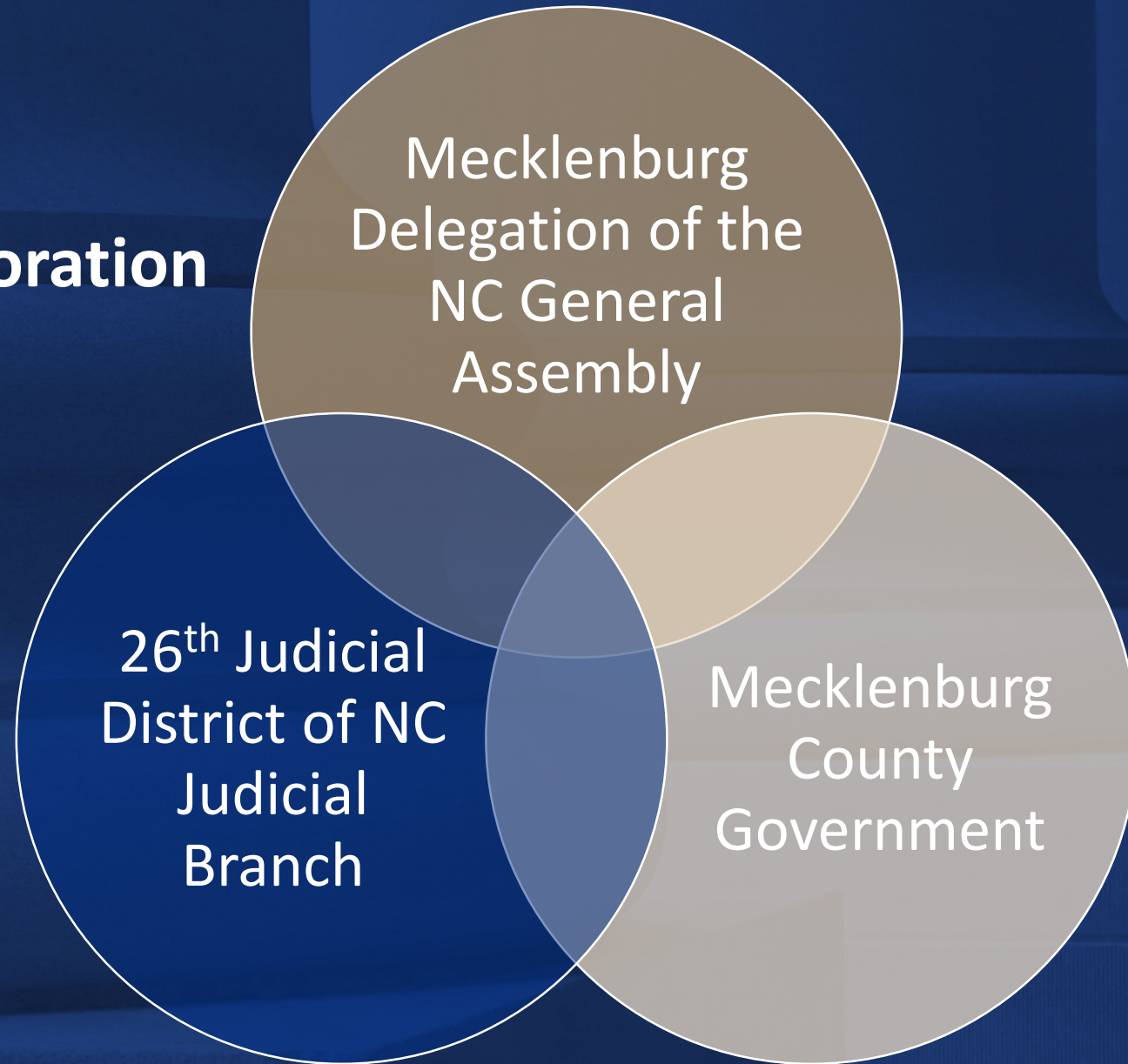
