NOTICE IS HEREBY GIVEN that on June 19, 2018, a public hearing, as required by Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), will be held by the Board of Commissioners of the County of Mecklenburg, North Carolina (the "Board") with respect to the proposed issuance by the Public Finance Authority (the "Authority"), a commission organized under and pursuant to the provisions of Sections 66.0301, 66.0303 and 66.0304 of the Wisconsin Statutes, as amended, of its Multifamily Housing Revenue Bonds (AHF Southeast Portfolio Acquisition), in one or more series (the "Bonds"), in an amount not exceed \$124,000,000, the interest on which will be excludible from gross income for federal income tax purposes. The hearing will commence at 6:30 p.m., or as soon thereafter as the mater can be heard, and will be held in the Commissioners' Meeting Room, 600 East 4th Street, Charlotte, NC 28202

The Bonds are expected to be issued by the Authority pursuant to 66,0304 of the Wisconsin Statutes, as amended, and the Authority will loan an approximately \$7,264,000 portion of the proceeds from the sale of the Bonds to the "Borrower" identified below and used to (i) finance the acquisition of an 101-unit, multifamily affordable housing development, known as Timber Ridge Apartments ("Project"), and (ii) pay certain fees and costs associated with the issuance of the Bonds.

The Project is located at 7123 Barrington Drive, Charlotte, North Carolina 28215. The Project will be owned by AHF-Timber Ridge, LLC, a Delaware limited liability company, of which Allantic Housing Foundation, Inc., a South Carolina nonprofit corporation and organization described in Section 501 (c)(3) of the Code, is the sole member (collectively, the "Borrower"). The maximum aggregate principal amount of tax-exempt Bonds proposed to be issued by the Authority in connection with the Project is \$124.000,000.

The Bonds will be special limited obligations of the Authority payable only from the loan re-payments to be made by the Borrower to the Authority, and certain accounts established by the trust indenture for the Bonds.
