### **Purpose**

The Mecklenburg County Board of County Commissioners hereby creates the Mecklenburg County Air Quality Commission (AQC) with the mission and duty to promote the protection, preservation, and enhancement of the ambient air resources of Mecklenburg County, North Carolina. The purpose of the AQC shall be to provide citizen and stakeholder input to the Board of County Commissioners, local municipalities and staff through the review and recommendation of air pollution management policies, long-range plans, operations and their budgetary impacts in order to achieve the above mission.

#### Qualifications

The membership of the Air Quality Control shall be divided according to the following vocations or interests represented: One (1) Health Professional (HP), One (1) Engineer (ENG), One (1) Industrial (I), One (1) Scientist (S), One (1) Environmental (E), One (1) Attorney (ATTY), One (1) Transportation (T), and Five (5) General Public (GP). The Board shall ensure that at least four (4) members shall reside in the City of Charlotte; at least one (1) member shall reside in the Town of Cornelius (COR), Davidson (D) or Huntersville (HUN) and one (1) member shall reside in the Town of Matthews (MAT), Mint Hill (MH) or Pineville (PINE). Must be a resident of Mecklenburg County.
