- 2. Committee meetings will be scheduled for the following dates and times (you may list tentative dates):

The Housing and Financial Stability Network meetings are held on the second Thursday of each month from 10 AM to 11 AM. The LIEAP program will be discussed at the September 13, 2018 and October 11, 2018 meetings.

- 3. The following agencies or groups will provide outreach services for CIP and/or LIEAP: The members of the Housing and Financial Stability Network and MedAssist. Mecklenburg County community partners will receive information about the energy program as well as pamphlets to distribute in the community. CAM is the primary outreach agency and the contracted administrator of the CIP program.
  - a. What outreach activities will each agency provide to those individuals and families with the lowest income and highest relative energy costs and needs? DSS staff will provide agencies with information and materials for distribution. DSS staff will also attend meetings to discuss the program.
  - b. What outreach activities will each agency provide to households with a member age 60 and over?

DSS will alert case managers and social workers from its Adult Protective Services, Community Social Work, Senior Nutrition Program (congregate and home delivered meals) areas about the LIEAP focus areas and ask them to complete applications for their clients. DSS will ensure that disabled persons receiving services through the Division of Aging and Adult Service (DAAS) are contacted and offered an opportunity to participate.

Externally, we will partner with Senior Centers, Park & Recreation Centers, Centralina Area on Aging, Mecklenburg County Office of Veteran Affairs, Charlotte Housing Authority locations and other community groups who serve senior and disabled clients. DSS will ask these to agencies provide LIEAP information to their staff and clients, and make the appropriate referrals.

LIEAP applications will be taken via home visits and phone interviews as needed.

- 4. Outreach for CIP and/or LIEAP will be coordinated between the county department of social services and each agency in number 3 above in the following ways: DSS staff will provide program information and materials for distribution to the listed agencies. DSS staff will also attend meetings to discuss the program.

#### **APPLICATION TAKING**

- a. CIP is a year-round program that runs <u>July 1<sup>st</sup></u> through <u>June 30<sup>th</sup></u> statewide.
  - LIEAP applications will be taken from <u>December 1<sup>st</sup></u> through <u>March 31<sup>st</sup></u> annually statewide.
- 2. The following agencies or groups will provide application-taking and processing services for CIP and/or LIEAP:

LIEAP applications will be taken by a combination of DSS staff and temporary employees. DSS will take applications at two locations: Kuralt and Chapin Hall offices. CIP applications will be taken at the two Crisis Assistance Ministry locations. The main location where applications will be recieved is 500-A Spratt St. The second location is in North Division, 212 Gamble St, Davidson, NC 28036, at the Ada Jenkins center.

- 3. Any additional comments or activities planned for CIP and/or LIEAP: None.
- 4. The maximum allowed CIP benefit amount per eligible household is \$600 per fiscal year (July 1 June 30). This applies to all counties.

This Outreach Plan applies to LIEAP and CIP only. Energy Neighbor, Share the Warmth, Wake Electric Round Up, and Helping Each Member Cope funds are not provided in Mecklenburg County, and are not governed by this Plan. Please refer to the appropriate Energy Programs policy manual sections for eligibility criteria regarding those funds.
