Review and comment on the annual operating budget for their respective service charge areas, including but not limited to, public education activities, customer service, and the building and collections system. Hear appeals and reach decisions on: service charges, credits, and adjustments. Hear requests for changes from City and County staff and from private parties and make recommendations to the City Council and the Board of County Commissioners on the following matters: the application, modification, and enforcement of storm water policies.
