SUBJECT: Uniform Schedules of Values, Standards and Rules for the 2019 Revaluation

In preparation for the 2019 revaluation, the Assessor is required to prepare a Uniform Schedules of Values, Standards and Rules ("SOV") to be used in appraising real property at its true value and at its present-use value. North Carolina General Statute (N.C.G.S.) 105-317 requires the Assessor to submit the proposed SOV to the Board of Commissioners ("Board") not less than 21 days before the meeting at which the proposed Schedules will be considered and requires that a copy of the proposed SOV be filed in the Assessor's Office where it will remain available for public inspection. The SOV will be delivered to the Board at its August 08, 2018 meeting.

The Board, upon receipt of the proposed SOV, is required to publish a statement in a newspaper having general circulation in the County stating that the proposed SOV are available for public inspection in the Assessor's Office and stating the time and place of a public hearing for considering the proposed SOV. A newspaper publication announcing a public hearing at the September 05, 2018 Board meeting is scheduled for August 10, 2018.

The adoption of the final SOV shall be made by the Board not less than seven (7) days after the public hearing. The SOV is scheduled for approval by the Board at its September 18, 2018 meeting.

When the Board approves the final SOV, it is required to issue an Order adopting them, and the Order must be published once a week for four (4) successive weeks in a newspaper having general circulation in the County, with the last publication being not less than seven (7) days before the last day for challenging the validity of the Schedules by appeal to the Property Tax Commission (PTC).

Copies of the proposed Schedules are hereby delivered to the Clerk for consideration at the August 8, 2018 meeting. The following timetable is proposed in connection with the final adoption of the Schedules:

July 23, 2018	Submission of Schedules to Clerk's office.
August 8, 2018	Delivery of Schedules to Board pursuant to N.C.G.S. 105-317. Board authorizes publication of Notice as set forth in Attachment 1.
August 10, 2018	Publication of Notice of Public Hearing in The Charlotte Observer, as set forth in Attachment 1.
September 5, 2018	Public hearing on proposed Schedules pursuant to N.C.G.S. 105-317.
September 18, 2018	Adoption of final Uniform Schedules of Values, Standards and Rules, as set forth in Attachment 2. Board authorizes publication for 4 weeks of Notice of Order Adopting Schedule of Values and appeal period to challenge the validity of the Schedule of Values, as set forth in Attachment 3.
September 21, 2018	First day for publication in The Charlotte Observer of the Order adopting the Schedules, as set forth in Attachment 3.
September 28, 2018	Publish Second Notice of Adoption.
October 5, 2018	Publish Third Notice of Adoption.
October 12, 2018	Publish Fourth Notice of Adoption.
October 22, 2018	Last day for challenging the validity of the Schedules by appeal to the PTC.

WHEREAS, pursuant to G.S. 105-286, Mecklenburg County will reappraise all real property in accordance with the provisions of G.S. 105-283 and G.S. 105-317; and

WHEREAS, pursuant to the provisions of G.S. 105-317, the Assessor for Mecklenburg County has submitted proposed Uniform Schedules of Values, Standards and Rules to the Board of Commissioners, which proposed Schedules have been available for public inspection since August 8, 2018 and were considered at a public hearing held on September 5, 2018; and

WHEREAS, a notice has been published in The Charlotte Observer of the submission to the Board of Commissioners of the proposed Schedules and the notice of public hearing.

NOW, THEREFORE, IT IS ORDERED that the final Uniform Schedules of Values, Standards and Rules attached to this Order are hereby adopted pursuant to G.S. 105-317 and approved for use in appraising real property at its true value and at its present-use value as of January 1, 2019. A Notice of the adoption of this Order shall be published once a week for four successive weeks in The Charlotte Observer; and the final Schedules shall be available for public inspection at the Office of the County Assessor, Suite 103, Robert L.
