Contract Administration may notify identified service providers of the release of the request by sending them an emailed link to the DSS NCIPS Internet sites. A minimum of four to six weeks time should be given to service providers for preparation of proposals depending on the complexity of the project. Attendance at pre-proposal conferences is encouraged but not mandatory. Addenda are posted to the Internet on the DSS and NCIPS
