# Item 2:

Support Maintaining State and Local ABC Board Management ABC Boards in North Carolina are local independent political subdivisions of the State. The Mecklenburg County ABC Board operates solely on revenue from spirit sales in Mecklenburg County.

In Fiscal Year 2018, the Mecklenburg County ABC Board distributed \$6,057,914 to Mecklenburg County.

5 Board Members are appointed by BOCC.

Legislative concerns about State ABC Board contract management may lead to privatization and jeopardize local boards.

# Item 3: Support County Use of Surplus CMS Property

Advocate to explore options for alternative use of surplus property.

General Statute 115C-518. Disposition of school property; easements and rights of way.

- When any real property to which the board holds title is no longer suitable or necessary for public school purposes, the board of county commissioners for the county in which the property is located shall be afforded the first opportunity to obtain the property.
- The board of education shall offer the property to the board of commissioners at a fair market price or at a price negotiated between the two boards.





#### Item 4: Support Re-establishing the Mountain Island Lake Marine Commission

The Mountain Island Lake Marine Commission between Gaston, Lincoln and Mecklenburg Counties dissolved in 2014.

Former commission's charge – work on water quality, shoreline issues and boating safety with Lake Manager Duke Energy and NC Wildlife Commission.

#### **Proposed Development**

#### Existing Statutory Authority

County can enter into public-private agreements with private party owners for the design and construction of park infrastructure that is:

- in Park Master Plan
- Adjacent or in close proximity to property owned by private owner
- Located on the property owned by private owner that will be transferred to or leased by county



Note: Park design shown is conceptual; park and access to park from West Blvd has not yet been designed.
