Project Mercury

About the Company



- Avidxchange, Inc. is a "software as a service"
 [SaaS] company founded in 2000 in Charlotte
- Avidxchange provides web-based accounts payable services for small to medium sized businesses across the county, helping customers save money by converting to all digital processes
- Avidxchange services enable their customers to access analytics and performance monitoring usually only available to larger companies with significant in-house resources



Project Mercury

Project Details

- \$42 million in new taxable investment
 - \$37,000,000 real property
 - \$5,000,000 personal property
- 1,229 new employees over 5 years
- \$68,000 average annual salary

- Avidxchange is growing rapidly after securing significant new financing in 2017
- Avidxchange is proposing a 225,000 s.f. building adjacent to new HQ to accommodate new positions


- Woodlands, TX (Existing facility)

 - o \$5,800,000 Local tax abatement
- Oklahoma City, OK
 - \$31,000,000 State cash grant

Estimated annual sales tax revenue in final year of grant is \$1,140,600








Project Mercury | Estimated Fiscal Impacts

- The Project meets all BIP criteria for a seven year grant
 - o 2 additional years as large impact
 - 2 additional years as existing industry
- The City of Charlotte approved a BIP grant of \$1,237,682 on February 25, 2019
- State of North Caroline approved incentives on December 19, 2018
 - o JDIG \$19,640,000
 - Customized Training \$1,700,000
