***Purpose***

The Library Board of Trustees was created by the North Carolina General Assembly and has full control and supervision of the Public Library System. It employs the staff and makes the rules governing the library. The Library Board of Trustees is an eleven member board with ten members appointed by the Board of County Commissioners and one by the Charlotte-Mecklenburg Board of Education.

***Qualifications***

Appointments are made for four-year terms with no one serving more than two consecutive full terms. Must be a resident of Mecklenburg County.

Dear Chairman Dunlap:

We're writing to review upcoming appointment activity for the Charlotte Mecklenburg Library Board of Trustees in preparation for actions by the Board of County Commissioners at meetings next month.

As a reminder, Charlotte Mecklenburg Library operates under the guidance of a volunteer Board of Trustees whose members give generously of their time, talent and treasure to support the Library's mission. Trustees do not receive compensation for serving on the Board. Trustees hire, direct and advise the Library CEO, approve organizational policies and an annual budget, and serve as advocates and ambassadors for the organization across the community. Our trustees are asked to support the organization financially with donations to our Library Foundation, subject to their individual financial circumstances.

#### Reappointment of Current Trustees

One Library Trustee will complete an unexpired term at June 30, 2019:

- Ailen Arreaza

Ms. Arreaza has served the Library Board with distinction since her arrival in 2017. She brings the valuable voice of "library parent" to the board, informed by her own experiences and those of her family. Her professional responsibilities as leader of a parent advocacy non-profit organization also help her to contribute to important discussions about library programming for children and their families. Ms. Arreaza has agreed to serve an initial full four-year term expiring at the conclusion of FY 2023 if reappointed.

#### Departing and Retiring Trustees

At June 30, 2019 the Library Board will say good-bye to a board leader who has contributed greatly over her two four-year terms:

- Molly Griffin

Ms. Griffin is completing her second full four-year term on the Library Board of Trustees this June. During her time on the Board, she served as Chair for two years and also as Nominating Chair. Ms. Griffin has served as an important voice and advocate for public education during her service on the Library board. Her wise counsel will be missed in our Board's strategic conversations.



### Considerations for Recruitment of New Library Trustees

The Library CEO, Board of Trustees Chair, and Nominating Committee Chair annually review the Board's composition with an eye on five things --- (1) depth and breadth of engagement; (2) skills, knowledge and experiences; (3) leadership potential; (4) diversity of all types; and (5) strategic priorities, to ensure that the Library's governing body has the capacity and capabilities to guide the organization. Recruiting priorities are determined based on unmet needs.

As we went through this process in 2019 the following trustee recruiting priorities were established:

- Board leadership --- The Library Board needs "bench strength" for the board chair position. Additional trustee capacity, knowledge, experience, and ability to commit time to leadership duties would enhance the Board's sustained ability to govern.
- Accounting and Finance --- The Library Board currently lacks a trustee with significant accounting and finance experience who can work with the Chief Capacity Officer on financial planning and reporting.
- Digital marketing --- Telling the Library story and reaching users and non-users with information to build usage remains one of the Library's biggest challenges. Board-level expertise would be helpful.
- Data analytics and customer relationship management --- Data gathering and analytics processes at the Library can be improved and would benefit from trustee involvement. The Library is lacking an effective customer relationship management tool to help serve library users. Candidates with CRM experience would be attractive to the organization.
- Corporate sector leadership --- The Library Board currently has two trustees from the corporate sector. Over time the Nominating Committee would like to broaden participation by the corporate sector to three of the eleven trustee slots.
- Commercial construction/real estate/capital project expertise --- The Library is in the midst of several funded and unfunded projects that would serve to extend and improve its delivery system. More experience at the Board level in commercial project development and distribution system optimization would be helpful to staff efforts.

### New Library Trustee Recommendation

On behalf of the Library Board, and based on the organization's identified volunteer leadership needs, we recommend the following local leader for appointment to the Board effective July 2019:

- Melissa McGuire

Ms. McGuire is the founder and owner of Sherpa, a staffing, recruiting and consulting firm headquartered in Charlotte. Sherpa specializes in accounting, finance, human resources, executive administration, marketing, information technology and project management.

Prior to forming Sherpa, Ms. McGuire spent 14 years with an international recruiting and staffing company. Previous to that, Ms. McGuire worked for Arthur Anderson in Charlotte and Deloitte in Minneapolis. She graduated with a BBA in Accounting from the University of Iowa with honors.

Ms. McGuire's knowledge and experience in accounting and staffing could be most useful to the Library in our financial activities and in our efforts to attract the best possible talent to the Library. The latter of these needs is becoming increasingly acute.

Ms. McGuire has been heavily engaged in our community. Among many other civic activities she has:

- Chaired the Charlotte Mecklenburg Community Foundation
- Served as Treasurer of the Board of Charlotte Center City Partners
- Served on the Executive Committee of the Charlotte Chamber (now Charlotte Regional Business Alliance)
- Chaired the Board of WFAE
- Chaired the Entrepreneurial Leadership Circle at the McColl School of Business at Queens University
- Helped found the Susan G. Komen for a Cure, Charlotte affiliate

Under her leadership Sherpa has been recognized as Best/Top Places to Work by both the Charlotte Observer and Charlotte Business Journal.

Ms. McGuire has agreed to serve on the Library Board of Trustees if appointed.

On a board of only eleven all of our trustees are counted on to provide the necessary stewardship for a largely publicly funded enterprise serving the needs of the entire county. Ms. McGuire would bring specific skills and experiences that address targeted gaps and complement our returning Board. We believe she would be a terrific Library trustee.

We recommend that Melissa McGuire fill Molly Griffin's expiring four-year term. Her initial four-year term would expire June of 2023, after which she would be eligible for a second four-year term ending 2027.

#### Board Mix

As a very public institution serving all of Mecklenburg County, we take seriously the responsibility of reflecting and including our community. The addition of Ms. McGuire would maintain the demographic mix of our Board of Trustees at its current level.


