***Purpose***

The Nursing Home Advisory Committee serves as a liaison between the Board of County Commissioners and local Nursing Homes. Appointments are made for one-year terms for the first year, and any member reappointed to a second or third- year term will be appointed for a three-year term, with no one serving more than two consecutive terms.

***Qualifications***

No person or immediate family member of a person with a financial interest in a home served by this committee, no employee or governing board member of a home served by this committee, and no immediate family member of a resident in a home served by this committee may be a member of this committee. Must be able to travel to each facility in the county. Be available to serve an average of eight (8) hours per month. Must be able to complete an initial orientation and field training of 15 hours. Must be a resident of Mecklenburg County.

**NOMINATIONS/APPOINTMENTS/REAPPOINTMENT NEEDED FOR:**

**1) Four (4) one-year terms expiring May 30, 2020**

**The Board can nominate and appoint William Hudson, Kelly McKinnon, Janice Robinson and Sharrone Robinson. This will bring the membership to 26.**

**2) Reappointment Consideration for Kay Roderick**

**The Ombudsman for the Nursing Home Community Advisory Committee is requesting the reappointment of Kay Roderick for a three-year term expiring May 30, 2022. Even though she's served the normal term limit, Ms. Roderick's continued service is vital, because she's assisting the Ombudsman with training new members.**

**Note: The highlighted applicants have been cleared for appointment. The remaining applicants are pending screening by the Ombudsman at the Centralina Council of Governments and will be brought forth at a later date.**

**Service on this committee requires a tremendous time commitment. There's also mandatory training which is conducted by the Ombudsman at the Centralina Council of Governments. The Nursing Home Advisory Committee is one of seven advisory boards that receive compensation. Members receive \$75/month.**
