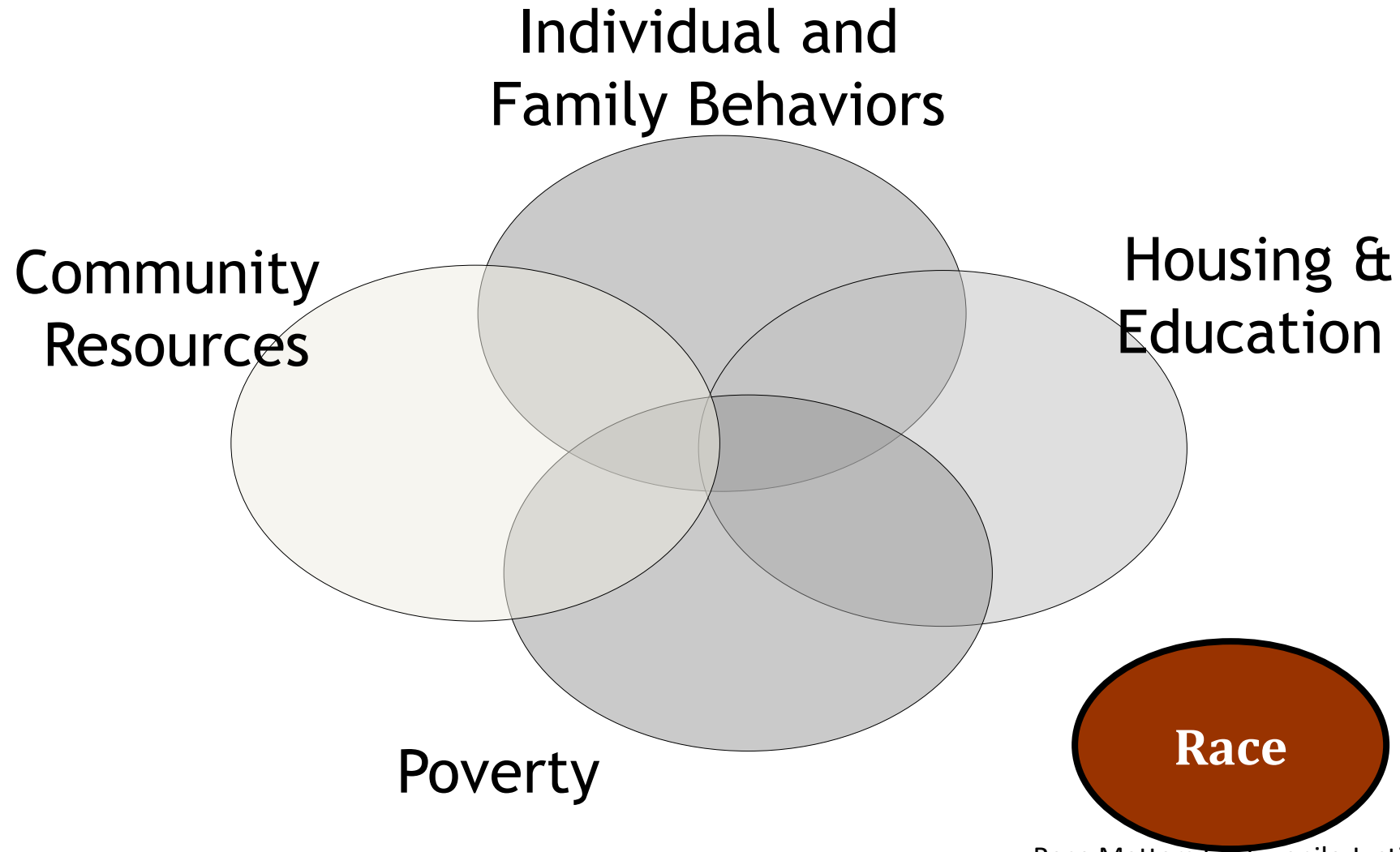


Race Matters for Juvenile Justice

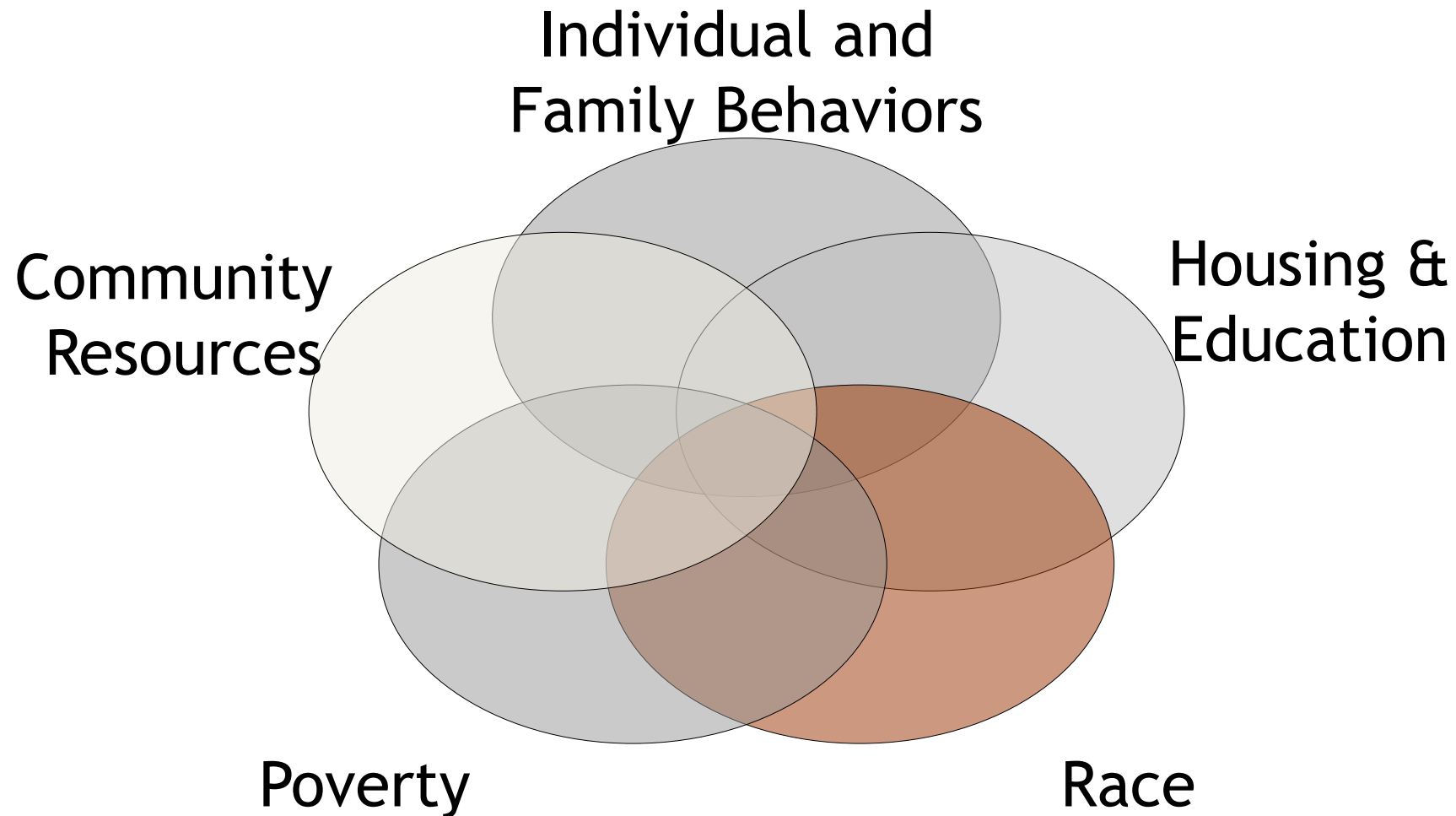

Our Composition

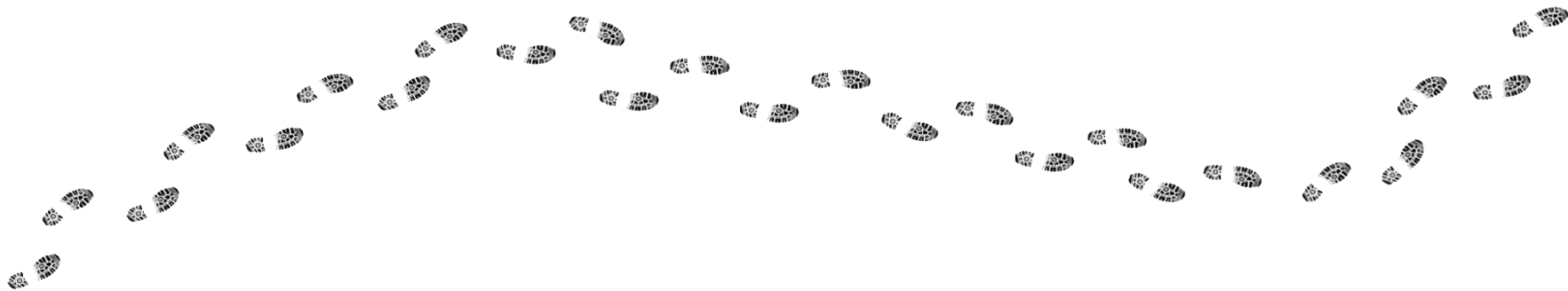
- We needed a few people with a strong desire.

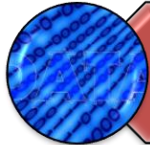
