### Qualifications

Must be able to travel to each facility in the county. Be available to serve an average of eight (8) hours per month. Must be able to complete an initial orientation and field training of 15 hours. Must be a resident of Mecklenburg County.

#### **NOMINATION/APPOINTMENT NEEDED FOR:**

One (1) one-year term expiring July 31, 2020.

The Board can nominate and appoint Jeremy Arey.
