
## VIII. Additional comments:



until her death in 2018, and having four children John (Atlanta, GA), Rick (Virginia), Anne (Charlotte, NC), and William (Charlotte, NC), along with grandchildren and great grandchildren. He majored in mechanical engineering and graduated in 1954. Traveled to several states working, and back to South Carolina in 1959. In 1965 he moved to Charlotte and in 1984 became involved in politics. He worked for 12 years for Chrysler Corporation's Airtemp Division and the Trane Company before later starting his own sales agency, J.G. Blackmon and Associate, which was located in Charlotte with sub-office in Raleigh, Greensboro, Greenville an Columbia. Eventually, he sold each office to its branch manager.
