# About the Company



- Lendingtree LLC was founded in Charlotte in 1996
- A leading online marketplace with one of the largest networks of lenders for home mortgages, personal loans, credit cards, business, automobile, and student loans
- Company headquarters is located in Charlotte and employs 488 persons with an average annual salary of \$94,000
- Lendingtree is in significant growth mode with its 2017 revenue of \$617 million more than doubling its 2015 revenue of \$254 million

- 7 year, 50% grant
- \$686,878 maximum grant value

LendingTree announced selection of Mecklenburg County as site for HQ

- > \$26,180,000 in new taxable investment
  - o \$19,680,000 real property
  - \$6,500,000 personal property
- → 436 new employees over five years
- ➤ \$101,140 annual salary
- 488 Positions in MecklenburgCounty retained

- \$10,000,000 HQ Tax Credits



- The City of Charlotte approved a 7 year, 90% BIP Grant of \$733,988 on June 10, 2019
- North Carolina has offered:
  - o JDIG- \$8,300,000
  - Customized Training -\$610,000



#### **Project Impacts**

- Induce 420 additional jobs by end of grant term
- \$504,000 in annual sales tax by end of grant term
- County to net \$391,800 in the final year of the grant term
- Cumulative net of \$1,844,100 to County at end of grant term





#### **BOCC Action**

 Adopt a resolution approving a Business Investment Program grant to LendingTree for a total estimated amount of \$686,878 and authorize the County Manager to negotiate and execute any and all necessary contract documents
