- Mosack Group purchased a portion of Apollo Valves as of June 30, 2018, and incorporated as a new company. It currently imports and sells residential plumbing products to large-scale commercial retailers.
- Currently leases space in Matthews and employs 50 people and seeks news pace to accommodate growth.
- Mosack Group will invest in a build to suit facility with corporate headquarters, distribution and PEX pipe extrusion manufacturing functions.



Mosack Group | Estimated Fiscal Impacts

- The project is estimated to induce 10 secondary jobs by the end of grant term
- The project is estimated to induce \$15,600 in annual sales tax by the end of grant term
- Net revenue in the final grant year is estimated to be \$36,000 with a cumulative net of \$189,600 over the life of the grant
