


OVERVIEW OF GENERAL FUND COUNTY REVENUE

General Fund Balance Policy

- The minimum of total General Fund Balance and Debt Service Fund combined to the General Fund actual revenues will be 28%
- If the General Fund Balance falls below the minimum 28% of total General Fund revenues, the <u>funds must</u>
 <u>be replenished</u> over the next two fiscal years
- The **Unassigned** Fund Balance will be maintained at a level sufficient to:
 - provide the resources to meet operating cost needs,
 - o allow for unforeseen needs of an emergency nature to permit orderly adjustments to changes resulting from termination or significant reductions in revenue sources
- o **Note**: Every fund balance dollar spent on a reoccurring expense will eventually need to be replaced with on-going revenue. Otherwise, the budget will have a **structural deficit**.



General Fund Balance Policy

Restricted: required by State Statue


Includes amounts not readily available to spend such as receivables, deferred revenue and encumbrances

Committed: Amounts Approved by the Board to be used for a specific purpose

Unassigned: portion that has not been restricted, committed or assigned to specific purpose or other funds
