PUBLIC HEARING NOTICE

The Mecklenburg County Board of Commissioners will hold a Public Hearing to receive comments on how to invest the Coronavirus Recovery Funds at its October 5, 2021 regular meeting at 6:30 p.m., or as soon thereafter as the item is reached on the agenda. As context, on May 10, 2021, the US Department of Treasury announced the launch of the Coronavirus State & Local Recovery Funds, established by the American Rescue Plan Act of 2021, to provide \$350 billion in emergency funding for eligible state, local, territorial governments. Mecklenburg County received a direct allocation in the amount of \$215 million from the US Department of Treasury. The funds will cover eligible cost incurred by December 31, 2024. The performance period to complete projects and investments runs until December 31, 2026. Due to COVID-19, the Charlotte-Mecklenburg Government Center is closed to the public. Therefore, the meeting will be held remotely. Members of the public can address the Board of County Commissioners via WebEx. **Persons desiring to speak** can sign up online at <https://mecknc.seamlessdocs.com/t/clerk> or call 980-314-2912. The deadline to register is 3:00 p.m. the day of the meeting. Speakers must provide an email address when registering to speak to receive the WebEx link to enter the meeting as a participant. Each speaker will receive up to three (3) minutes to speak. Members of the public may also view the meeting on the Government Channel, or online watch.mecknc.gov. 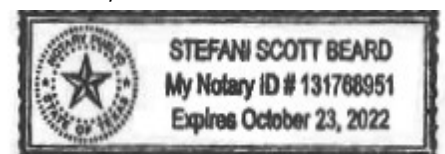
